3. Jeffrey S. Grand shall consent to the appointment of the Clerk of the Superior Court as an agent upon whom service of process may be made for all actions against him and his firm that may arise out of his participation in this matter;


4. Jeffrey S. Grand shall notify the Court immediately of any matter affecting his standing before this Court;

5. Jeffrey S. Grand shall have all pleadings, briefs and other papers filed with the Court signed by an attorney-at-law of this Court, authorized to practice in this State, who shall be responsible for the conduct of Jeffrey S. Grand, Esq., and it is;

ORDERED that Jeffrey S. Grand, Esq. shall make payment of all fees due to the State of New Jersey within 30 days of the entry of the *pro hac vice* Order allowing for admission and as provided in the New Jersey Rules of Court, *R. 1:20-1(b)*, *1:28-2* and *1:28B-1(e)* and it is further;

ORDERED that a copy of this Order shall be served by attorneys for Plaintiffs upon defendants within seven (7) days of their receipt thereof.
