**ORDER REGARDING *PRO HAC VICE*
ADMISSION OF JENNIFER
STONECIPHER HILL, ESQUIRE**

THIS MATTER having come before the Court on the Motion of Defendants for an Order admitting attorney Jennifer Stonecipher Hill, Esquire of Shook Hardy & Bacon, LLP in Kansas City, Missouri, *pro hac vice* in the above captioned matter; and the Court having read and considered all submissions in connection with application; and good cause appearing;

IT IS on this 8 day of March, 2013,

ORDERED that Jennifer Stonecipher Hill be admitted *pro hac vice* and is authorized to appear and participate with other counsel for Defendants in all phases of the trial, subject to the following conditions:

1. Jennifer Stonecipher Hill shall abide by the Rules Governing the Courts of the State of New Jersey, including all disciplinary rules, R. 1:20-1 and R. 1:28-2.

2. Jennifer Stonecipher Hill shall and hereby does consent to the appointment of the Clerk of the Supreme Court as her agent upon whom service of process may be made for all actions against her or her firm that may arise out of her participation in this matter.

3. Jennifer Stonecipher Hill shall notify the Court immediately of any matter affecting her standing at the Bar of any other jurisdiction.

4. Jennifer Stonecipher Hill shall have all pleadings, briefs, and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey who shall be held responsible for her, the conduct of the litigation, and of the admitted attorneys herein.

5. Jennifer Stonecipher Hill cannot be designated as trial counsel.


6. No delay in discovery, motions, trial, or any other proceeding shall occur or be requested by reason of the inability of Jennifer Stonecipher Hill to be in attendance.

7. Jennifer Stonecipher Hill, or Stradley Ronon Stevens & Young, LLP, on her behalf, shall pay the fee required by R. 1:20-1(b) and R. 1:28-2 within 10 days upon receipt of this Order, and shall submit an affidavit of compliance.

8. *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1(b) and R. 1:28-2.

9. Non-compliance with any of these requirements shall constitute grounds of revocation of Jennifer Stonecipher Hill *pro hac vice* admission.

10. A copy of this Order shall be served on all counsel of record within seven (7) days of the date hereof.
