**ORDERED THIS** 4th day of October 2019;

1. Daniel C. Burke, Esq. shall be and is admitted to practice *pro hac vice* before this Court pursuant to *R. 1:21-2*, for all purposes and in all proceedings in which he or his firm, Bernstein Liebhard LLP, have filed and served action, in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey;

2. Daniel C. Burke, Esq. shall abide by the Rules of Court for the State of New Jersey, including all disciplinary rules, *R 1:20-1* and *R 1:28-2*;

3. Daniel C. Burke, Esq. shall consent to the appointment of the Clerk of the Superior Court as an agent upon whom service of process may be made for all actions against him and his firm that may arise out of his participation in this matter;

4. Daniel C. Burke, Esq. shall notify the Court immediately of any matter affecting his standing before this Court;

5. Daniel C. Burke, Esq. shall have all pleadings, briefs and other papers filed with the Court signed by an attorney-at-law of this Court, authorized to practice in this State, who shall be responsible for the conduct of Daniel C. Burke, Esq., and it is;

**ORDERED** that Daniel C. Burke, Esq. shall make payment of all fees due to the State of New Jersey within 30 days of the entry of the *pro hac vice* Order allowing for admission and as provided in the New Jersey Rules of Court, *R. 1:20-1(b)*, *1:28-2* and *1:28B-1(e)* and it is further;

**ORDERED** that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection, and it is further;

**ORDERED** that a copy of this Order shall be served by attorneys for Plaintiffs upon defendants within seven (7) days of their receipt thereof.
