**ORDERED THIS** 13th day of September 2019;

1. Daniel C. 5. Daniel C. Burke, Esq. shall have all pleadings, briefs and other papers filed with the Court signed by an attorney-at-law of this Court, authorized to practice in this State, who shall be responsible for the conduct of Daniel C. Burke, Esq., and it is;
