
IT IS on this 11<sup>th</sup> day of October, 2016,

IT IS HEREBY ORDERED that Ali Azadi, M.D., whose place of business is Norton Women's Specialists at 4123 Dutchmans Lane, Suite 307, Louisville, KY 40207, shall produce to Defendants Ethicon, Inc. and Johnson & Johnson, any and all patient intake forms or questionnaires, whether filled out by the Susan Smith or office staff, relating in any way to the medical care and treatment of Susan Smith, or relating to any interactions, office visits, procedures and/or medical care provided by Dr. Azadi and any of his office staff to Susan Smith, within 10 days of this Order; and

IT IS FURTHER ORDERED that a Commission for a Subpoena *Duces Tecum* to Ali Azadi, M.D., whose place of business is Norton Women's Specialists at 4123 Dutchmans Lane, Suite 307, Louisville, KY 40207, shall immediately issue, and the Clerk of the Court shall cause the proper seal to be affixed to the Commission.

ORDERED that a "filed" copy of this Order be served upon opposing counsel within 30 days of the date hereof.
