THIS MATTER having been opened to the Court by Aylstock, Witkin, Kreis & Overholtz, PLLC, counsel for Plaintiffs, and counsel for Defendants Ethicon, Inc., Ethicon Women's Health and Urology, Gynecare and Johnson and Johnson (hereinafter referred to as the "Defendants"); and

WHEREAS, on various dates in June 2015, Aylstock, Witkin, Kreis & Overholtz, PLLC filed 140 individual Complaints in the above-referenced Master Case; and


WHEREAS, these Complaints (hereinafter referred to as "The Aylstock Cases") are identified in **Exhibit A** attached hereto; and

WHEREAS, the parties seek to minimize the administrative and logistical burden that the group filing of The Aylstock Cases will place on the Court and the parties; and

WHEREAS, all parties consent to the entry of this Order, and for good cause shown, IT IS on this 23 day of Sept, 2015, ORDERED that:

1. The provisions contained herein apply only to The Aylstock Cases referenced above and shall not be construed as impacting or amending any prior Orders or other cases in the In re: Pelvic Mesh/Gynecare Litigation;
2. Beginning on August 31, 2015, Plaintiffs' counsel will serve 40 Plaintiff Fact Sheets upon Riker Danzig per month until all the Plaintiff Fact Sheets are served in The Aylstock Cases;
3. Beginning on October 15, 2015, Defendants' counsel will serve corresponding Defendant Fact Sheets in a minimum of 10 Aylstock Cases per week, in the order of receipt of Plaintiff Fact Sheets, until all the Defendant Fact Sheets are served in The Aylstock Cases;


4. Plaintiffs' counsel may serve the Plaintiff Fact Sheets in The Aylstock Cases electronically via CD or DVD;
5. Plaintiffs' counsel and Defendants' counsel shall serve copies of Plaintiff Fact Sheets and Defendant Fact Sheets on Plaintiffs' liaison counsel as provided for in CMO No. 5, paragraph 7; and


