**ORDERED**, that Allan Zelikovic, Esq., shall abide by the rules governing the State of New Jersey, including all disciplinary rules; consent to the appointment of the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against the attorney or the attorney's firm that may arise out of the attorney's participation in the matter; notify the Court immediately of any matter affecting the attorney's standing at the bar of any other court; and have all pleadings, briefs and other papers filed with the Court signed by an attorney of record authorized to practice in this State, who


shall be held responsible for them and for the conduct of the cause and of the admitted attorney therein;

**ORDERED**, that the admission of Allan Zelikovic, Esq., shall not be cause for any adjournment in this matter; and it is further
