ORDERED, Allan Zelikovic, Esq., shall notify the Court immediately of any matter affecting his standing at the Bar of any other jurisdiction; and it is further

ORDERED, that Allan Zelikovic, Esq., shall have all pleadings, briefs and other papers filed

with the Court signed by an attorney of record authorized to practice in this State, who shall be held responsible for them and for the conduct and cause of Allan Zelikovic, Esq.; and it is further

ORDERED, that Allan Zelikovic, Esq., shall be required to pay the New Jersey Lawyers' Fund for Client Protection, as required by all New Jersey attorneys pursuant to R. 1:28-1, and he agrees to make said contribution for subsequent years when they are due; and it is further

ORDERED, that the admission of Allan Zelikovic, Esq., shall not be cause for any adjournment in this matter; and it is further

ORDERED, that a copy of this Order shall be served upon all counsel within 7 days of its receipt by the movant.
