attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that:


1. Ms. London shall abide by the Rules of the Court for the State of New Jersey and all disciplinary rules;
2. Ms. London shall and hereby does consent to the appointment of the Clerk of the Supreme Court as her agent upon whom service of process may be made for all actions against her or her respective firm that may arise out of his participation in the matter;
3. Ms. London shall notify the Court immediately of any matter affecting her standing at the bar of any Court; and
4. Ms. London shall have all pleadings, briefs and other papers filed in this Court signed by an attorney authorized to practice in this State who shall be responsible for them and for the conduct of the cause of Sarah R. London, Esquire therein.
5. Sarah R. London, Esquire shall make payment of fees as provided in the New Jersey Rules of the Court, R. 1:20-1(b), 1:28-2 and 1:28B-1(e).

IT IS FURTHER ORDERED THAT

That the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and

IT IS FURTHER ORDERED THAT a copy of this Order shall be served on all parties within seven (7) days of the date hereof.
