Fleishman, of the law firm of Lieff Cabraser Heimann & Bernstein, LLP, and the Court having considered the papers in support thereof,

IT IS ON THIS 25 day of Sept, 2012

ORDERED that the Motion is granted and Wendy R. Fleishman is admitted to practice *Pro Hac Vice* before this court pursuant to R. 1:21-2, for all purposes and in all proceedings in connection with the above-captioned action, and as listed on the attached Schedule A, in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that she shall:

1. Abide by the Rules of Court for the State of New Jersey, including all disciplinary rules;

2. Consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against her and her firm that may arise out of her participation in this matter;


3. Notify the Court immediately of any matter affecting her standing before this Court; and

4. Have all pleadings and other papers filed in this Court signed by an attorney at law of this Court employed by the firm of Lieff Cabraser Heimann & Bernstein, LLP, who shall be responsible for the conduct of Wendy R. Fleishman, and it is further

ORDERED that Wendy R. Fleishman shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2 and 1:28b-1(e), within thirty (30) days of the date of this order, and it is further

ORDERED that the Clerk of this Court shall forward a copy of this order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

ORDERED that copies of this Order shall be served by attorneys for Plaintiff upon counsel for the defendants within seven (7) days of the receipt thereof.
