Supreme Court as agent upon whom service of process may be made for all actions against the attorney or the attorney's firm that may arise out of the attorney's participation in the matter; notify the Court immediately of any matter affecting the attorney's standing at the bar of any other court; and have all pleadings, briefs and other papers filed with the Court signed by an attorney of record authorized to practice in this State, who shall be held responsible for them and for the conduct of the cause and of the admitted attorney therein; and it is further

ORDERED, that Allan Zelikovic, Esq., shall make payment of fees as provided by the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2, and 1:28b-1(e), within thirty (30) days of the date of this order; and it is further

ORDERED, the Clerk of the Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further

ORDERED, that the admission of Allan Zelikovic, Esq., shall not be cause for any adjournment in this matter; and it is further

ORDERED, that a copy of this Order shall be served upon all counsel within 7 days of its receipt by the movant.
