: **ORDER**

THIS MATTER having come before the court during a case management conference on April 30, 2019, concerning a scheduling order for the above-captioned action; and counsel for plaintiff and counsel for defendant PLIVA, Inc. ("PLIVA") having met and conferred and

reached agreement regarding this amended scheduling order; and good cause having been shown;


IT IS on this 4th day of June, 2019,

ORDERED as follows:

1. Depositions of individuals identified as potential PLIVA trial witnesses in this action shall be completed by **June 14, 2019**.
2. Designation of plaintiff experts and expert reports shall be served on or before **June 25, 2019**.
3. Designation of defendant experts and expert reports shall be served on or before **July 23, 2019**.
4. Expert discovery shall be completed by **August 16, 2019**.
5. *De bene esse* depositions of fact witnesses whose fact depositions already have been taken in this action shall be completed by **August 16, 2019**.
6. Dispositive and Kemp motions shall be filed by **August 23, 2019**. Opposition to any such dispositive or Kemp motions shall be filed no later than fourteen (14) days after the filing of the motions, and reply submissions shall be filed no later than seven (7) days after the filing of oppositions. The return date(s) shall be as set by the Court.
7. Motions in limine shall be filed by **September 9, 2019**. Opposition to any such motions in limine shall be filed by **September 23, 2019**.
8. Plaintiff and defendant shall exchange proposed deposition designations by **September 13, 2019**. Objections to any such deposition designations shall be exchanged by **September 20, 2019**. Plaintiffs and defendants shall meet and

confer to resolve any such objections during the week of **September 23, 2019**, with written objections to any remaining and/or unresolved objections to be provided by **October 4, 2019**.

9. Plaintiffs and defendant shall exchange proposed exhibit lists and witness lists by **September 16, 2019**. Objections to exhibit lists and witness lists shall be exchanged by **September 27, 2019**. Plaintiff and defendant shall provide final exhibits lists and witness lists to the Court by **October 4, 2019**.
10. Plaintiff and defendant shall provide a one-page joint statement of the case for the jury pool and a joint submission of jury voir dire by **October 7, 2019**. Plaintiff and defendant shall submit a proposed jury charge and a proposed verdict sheet by **October 7, 2019**.
11. A status conference will be conducted at 10:00 a.m. on **September 17, 2019**.
12. A final pretrial conference will be conducted at 10:00 a.m. on **October 8, 2019**.
13. The trial date shall be **October 21, 2019**.
