**GOVERNING ALL REGLAN®/METOCLOPRAMIDE CASES**

**SPREADSHEET**

**THIS MATTER** having being brought on the court's own motion, and for good cause shown;

IT IS ON THE 12 day of Nov 2010, ORDERED in accordance with the Court's directive at the \_\_\_\_\_ Case Management Conference, and to facilitate greater organization and access for cases in the Reglan/Metoclopramide litigation, the Court will be constructing a database of filed cases. To ensure the accuracy of this database plaintiffs' counsel is required to complete the Court provided spreadsheet for each of its filed cases.

Upon receipt of correspondence from the Court regarding construction of a database and completion of the spreadsheet for use in that database, plaintiffs' counsel with under 10 cases on file will complete the Court's spreadsheet within two weeks. Plaintiffs counsel with 25 cases or fewer shall complete the Court's spreadsheet within 30 days; while plaintiffs; counsel with more than 25 cases on file shall complete the Court spreadsheet within 45 days. The Court's spreadsheet will not be binding on plaintiffs. Plaintiff's counsel will provide to defendant's liaison counsel with a copy of each individual spreadsheet submitted to the Court.

No additional cases should be added by plaintiffs' counsel to the spreadsheet sent by the Court. To the extent that the spreadsheet lacks a filed case, plaintiffs' counsel should notify the Court through separate email. Finally data should not be cut and pasted into the spreadsheet as that will make the data incompatible with the database. (Attached hereto as Exhibit A is a letter to Reglan Counsel from the Court outlining the above process).
