**CASE MANAGEMENT ORDER NO. 30**

**THIS MATTER** having been brought before the Court at a case management conference on February 27, 2018, and counsel for plaintiffs and counsel for defendants having been present, and for good cause shown,

**IT IS** on this <sup>20</sup> day of March, 2018,

**ACKNOWLEDGED THAT** Case Management Order ("CMO") No. 29 required plaintiffs' counsel in cases where release deficiencies remained unresolved for CMO 26 Defendants to appear in-person before the Court at the February 27, 2018 conference, so that the Court could resolve any remaining release deficiencies. As of the February 27, 2018 conference fourteen plaintiff release deficiencies remained outstanding as to the CMO 26 Defendants and the Court addressed each such deficiency during the conference; and

**IT IS FURTHER ACKNOWLEDGED THAT** a failure by such plaintiffs to comply with this Order could result in those plaintiffs being precluded from participating in one or more of the CMO 26 Defendants' settlements and having their allocated share of those settlements distributed to other participating plaintiffs; and accordingly,

**IT IS ORDERED THAT** counsel for Plaintiff Roxanne Bay (L-10107-14) shall have 30 days from the date of this order to return a corrected release or counsel for Schwarz and/or Wyeth are permitted to file a proposed order converting the basis for dismissal with prejudice of claims asserted against them; and


**IT IS ALSO ORDERED THAT** counsel for plaintiff Gail Young (L 10421-14) shall have 15 days from the date of this order to return a corrected release, otherwise counsel for Wyeth and Pliva are permitted to file a motion to dismiss consistent with Case Management Order 25 dismissing the claims asserted against them; and

**IT IS FURTHER ORDERED THAT** counsel for plaintiffs Dale Emmett (L-01601-17), Mildred Sizemore (L-10266-14), Ambria Albinakis (L-10091-14), Craig Lynn (L-10186-14), and Mecca Guillame (L-10104-14) have 15 days from the date of this Order to return a corrected release, otherwise counsel for Alaven and/or Wyeth, as applicable, are permitted to file proposed orders converting the basis for dismissal with prejudice of claims asserted against them; and

**IT IS FURTHER ORDERED THAT** counsel for plaintiffs Robert Charles (L-01607-17), Thelma Wendt (L-10255-14), and Paul Reeves (L-10257-14) have 30 days from the date of this Order to return a corrected release, otherwise counsel for Alaven and/or Wyeth, as applicable, are permitted to file proposed orders converting the basis for dismissal with prejudice of claims asserted against them; and

**IT IS FURTHER ORDERED THAT** counsel for plaintiffs Eva Steele (L-10152-14) and Charles Shumway (L-10176-14) have 90 days from the date of this Order to initiate court proceedings to substitute an appropriate representative with authority to execute the required release(s) and supporting documentation, otherwise counsel for Actavis, Alaven, Schwarz and/or Wyeth, as applicable, are permitted to file proposed orders converting the basis for dismissal with prejudice of claims asserted against them.
