**JOINT STIPULATION OF DISMISSAL  
WITH PREJUDICE**

IT IS HEREBY STIPULATED AND AGREED, by and between the Parties to this Stipulation, through their respective counsel, that Defendants, MORTON GROVE PHARMACEUTICALS, INC. and WOCKHARDT USA LLC (collectively, "Morton Grove"), are hereby dismissed with prejudice and pursuant to Settlement from the individual matters listed on the annexed Exhibit A (the "Settling Plaintiffs").

The Parties further stipulate and agree that the individual matters listed on the annexed Exhibit B (the "Dismissed Plaintiffs") have been or will be dismissed with prejudice pursuant to the Case Management Orders and/or Dismissal Orders of this Court.

The Plaintiffs identified on the annexed Exhibit A and Exhibit B further stipulate and specifically agree that they hereby waive any and all appellate actions.

The Parties also stipulate and agree that Plaintiffs in the individual matters listed on the annexed Exhibit A and Exhibit B expressly reserve all claims as against any other active Defendants.

A corresponding Order of Disposition for those Settling Plaintiffs is annexed as Exhibit C.

IT IS SO STIPULATED.

Now therefore:

I. Pursuant to this Joint Stipulation and the accompanying Order of Disposition, it is Ordered that all claims asserted against Morton Grove, by or on behalf of the Settling Plaintiffs,

are hereby dismissed with prejudice, with each side to bear its own costs and fees in accordance with the Master Settlement Agreement and Release; and

2. Pursuant to this Joint Stipulation and Order, it is hereby Ordered that the only remedy or recourse for Settling Plaintiffs to resolve their individual claims against Morton Grove are the funds that Morton Grove deposits into the Qualified Settlement Fund under the terms of the Morton Grove Master Settlement Agreement.
