THIS MATTER having come before the court during a case management conference on November 8, 2018, concerning a scheduling order for the above-captioned action; and counsel for plaintiff and counsel for defendant PLIVA, Inc., having met and conferred and reached agreement regarding said scheduling order; and good cause having been shown;


IT IS on this 20<sup>th</sup> day of February, 2018,

ORDERED as follows:

1. Fact discovery shall be completed by **February 8, 2019**.
2. Choice of law motions shall be filed by **January 18, 2019**. Opposition to any such choice of law motions shall be filed by **February 1, 2019**, and reply submissions shall be filed by **February 8, 2019**. The return date shall be **February 15, 2019** or as otherwise set by the Court.
3. *De benne esse* depositions of medical fact witnesses shall be completed by **February 22, 2019**.
4. Designation of plaintiff experts and expert reports shall be served on or before **March 4, 2019**.
5. Designation of defendant experts and expert reports shall be served on or before **April 1, 2019**.
6. Expert discovery shall be completed by **April 26, 2019**.
7. Dispositive and Kemp motions shall be filed by **May 3, 2019**. Opposition to any such dispositive or Kemp motions shall be filed by **May 17, 2019**, and reply submissions shall be filed by **May 24, 2019**. The return date shall be **June 7, 2019** or as otherwise set by the Court.
8. Motions in limine shall be filed by **June 7, 2019**. Opposition to any such motions in limine shall be filed by **June 21, 2019**.
9. Plaintiff and defendant shall exchange proposed deposition designations by **June 11, 2019**. Objections to any such deposition designations shall be exchanged by **June 24, 2019**. Plaintiffs and defendants shall meet and confer to resolve any such

objections during the week of **June 24, 2019**, with written objections to any remaining and/or unresolved objections to be provided by **July 1, 2019**.

10. Plaintiffs and defendant shall exchange proposed exhibit lists and witness lists by **June 14, 2019**. Objections to exhibit lists and witness lists shall be exchanged by **June 24, 2019**. Plaintiff and defendant shall provide final exhibits lists and witnesses lists to the Court by **July 1, 2019**.
11. Plaintiff and defendant shall provide a one-page joint statement of the case for the jury pool and a joint submission of jury voir dire by **July 1, 2019**. Plaintiff and defendant shall submit a proposed jury charge and a proposed verdict sheet by **July 1, 2019**.
12. The trial date shall be **July 15, 2019**.
