IT IS on this 2 day of Aug, hereby



1. abide by the Rules of the Court for the State of New Jersey, including all disciplinary rules;
2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him or his firm that may arise out of his participation in this matter;
3. notify the Court immediately of any matter affecting his standing at the bar of any Court; and
4. have all pleadings, briefs and other papers filed in this Court signed by an attorney-at-law of this Court employed by the law firm of Dechert LLP, who shall be responsible for them, for the conduct of the cause and of Amir Nassihi, Esq., it is further

**ORDERED** that Amir Nassihi, Esq. shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:20-1(b), 1:28-2 and 1:28B-1(e) and it is further
