
practice in this state, and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that he shall:

2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against him and his firm that may arise out of his participation in these matters;
3. notify the Court immediately of any matter affecting his standing before this Court; and
4. have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm Reilly, Janiczek & McDevitt, P.C., who shall be responsible for the conduct of Richard Ben-Veniste, Esquire, and it is further

ORDERED that Richard Ben-Veniste shall make payment of fees as provided in Rules 1:20-1(b), 1:28-2 and 1:28B-1(e); and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is further
