**CASE MANAGEMENT ORDER
NO. 25**

THIS MATTER having come before the Court on November 30, 2009 for a conference concerning the schedule for pretrial motions and other submissions, pretrial hearings, and trial for the AstraZeneca bellwether cases, and for good cause shown:

IT IS on this 3rd day of December, 2009 **ORDERED** as follows:

The deadlines established by Case Management Orders 15 and 23 are hereby amended as follows:

1a. All dispositive motions and motions relating to the admissibility of expert testimony (*Kemp*/Rule 702), except those motions filed by plaintiffs on November 25, 2009, shall be served and filed according to the following schedule:

- i. Motions Filed: November 12, 2009
- ii. Opposition Filed: December 2, 2009
- iii. File reply - December 9, 2009
- iv. Oral argument: Oral argument of non-expert related dispositive motions will be held on December 14, 2009 following the Case Management Conference
- v. Any *Kemp* hearings deemed necessary by the Court will be held on dates to be scheduled ~~by the Court~~ between January 4-22, 2010.

1b. Defendants' opposition to plaintiffs' motions filed on November 25, 2009 shall be filed and served on December 9, 2009. Plaintiffs waive any reply briefs on those motions.

1c. All *in limine* motions shall be served and filed according to the following schedule:

- v. Motions filed: November 12, 2009
- vi. File opposition: December 4, 2009
- vii. File reply: December 11, 2009
- viii. Oral argument: To be scheduled by the Court if deemed necessary.

2. The schedule for the exchange and submission of deposition designations shall be as follows:


- i. Exchange proposed deposition designations: December 4, 2009
- ii. Exchange objections and counter-designations: December 14, 2009
- iii. Exchange objections to counter-designations: December 28, 2009, JCA
- iv. Counsel for the parties to meet and confer regarding deposition designations during the week of January 4-8, 2010

3. The schedule for the exchange and submission of proposed exhibit lists and witness lists shall be as follows:

- i. Exchange proposed exhibit lists and witness lists no later than December 14, 2009
- ii. Serve objections no later than December 28, 2009
- iii. Submit final exhibit lists and updated witness lists to the Court no later than February 8, 2010

4. The one page joint statement of the case for the jury pool, the joint submission of questions for the jury voir dire, proposed jury charges and verdict sheet shall be submitted to the Court no later than January 14, 2010.

5. All of the aforementioned documents to be filed with the Court shall be filed by 12:00 p.m. on the due date.
6. Trial shall commence on Tuesday, February 16, 2010.
