**CASE MANAGEMENT ORDER No. 37**

**THIS MATTER** having come before the Court on September 14, 2010 concerning the ease management of all pending New Jersey state cases in the above-captioned litigation, and good cause having been shown;


**IT IS** on this 15<sup>th</sup> day of **SEPTEMBER 2010** *effective from the conference date;*

**ORDERED** as follows:

1. As to Estate of Margaret Crowley (L-9446-06), defendant AstraZeneca may file a motion to dismiss plaintiff's complaint without prejudice for failure to provide a completed Long Form PFS with authorizations and/or acknowledgments for a return date no sooner than **October 1, 2010**.
2. Defendant Janssen may file motions to dismiss plaintiffs' complaints without prejudice for failure to provide completed Long Form PFSs with authorizations and/or acknowledgments for a return date no sooner than **October 1, 2010** in the following cases:  

Maria Rodriguez	L-9062-06
Jenai Putignano	L-729-06
Linda Tomblin	L-632-06
3. As to Sheila West (L-2263-10), defendant AstraZeneca may file a motion to dismiss plaintiff's complaint with prejudice for a return date no sooner than **October 15, 2010**. Plaintiff's counsel may file a motion to reinstate plaintiff's complaint for a return date of **October 15, 2010**.
4. Defendant AstraZeneca shall produce the SAS database to counsel for plaintiffs no later than **September 24, 2010**.

5. Counsel for defendant AstraZeneca shall provide the Blenkinsopp documents/materials in its possession and/or control to counsel for plaintiffs no later than **September 30, 2010**. Counsel for plaintiffs shall provide the Blenkinsopp documents/materials in their possession and/or control to counsel for defendant AstraZeneca no later than **October 14, 2010**.
6. For the discovery depositions of plaintiffs' physicians in the cases selected for the bellwether trials, counsel for plaintiffs and counsel for defendant AstraZeneca shall alternate as lead counsel in the conducting of those depositions.
7. As to depositions of defendant AstraZeneca corporate representatives, counsel for plaintiffs shall submit their position papers to the court no later than noon on **September 28, 2010**. Counsel for defendant AstraZeneca shall submit a response within two weeks of receipt of plaintiffs' position paper. Plaintiffs' counsel shall submit a reply, if necessary, within one week of receipt of defendant AstraZeneca's response.
8. The next Case Management Conference is scheduled on **October 21, 2010 @ 10:00 a.m.** in **courtroom 403**. Any joint agenda items and submissions shall be submitted to the Court by **noon on October 14, 2010**.
