**CASE MANAGEMENT ORDER NO. 58**

**THIS MATTER** having come before the court on June 1, 2012, concerning the case management of all pending New Jersey state cases in the above-captioned litigation, and good cause having been shown;

**IT IS** on this 1<sup>st</sup> day of **June, 2012**:

**ORDERED** as follows:

1. Counsel for defendant Janssen may file motions to dismiss the following complaints without prejudice for failure to comply with discovery obligations:
  - a. DeLisa Grant, Docket No. L-9050-06;
  - b. Rita Hodges, Docket No. L-6740-06;
  - c. Mary Kender, Docket No. L-6690-09;
  - d. Lywanda Looney, Docket No. L-498-07;
  - e. Patrick Bruck, Docket No. L-3315-07;
  - f. Percival Stacy, Docket No. L-6827-06; and
  - g. Tracey Bliss, Docket No. L-9064-06.

The motions to dismiss set forth in Paragraph 1 shall be returnable no earlier than **June 29, 2012**

2. No later than **June 8, 2012**, counsel for plaintiffs Melissa Ryker, Docket No. L-506-07, and Jeannine Jordan, Docket No. L-9455-10, shall provide outstanding discovery to counsel for defendant Janssen.
3. No later than **June 8, 2012**, counsel for plaintiff Phillip Abbott, Docket No. L-9110-06, shall provide to counsel for defendant Janssen information concerning this plaintiff's

discharge from the bankruptcy court and the validity of plaintiff's claims pending before this court based upon the bankruptcy court's discharge order.

4. Counsel for defendant Janssen may file motions to dismiss the following complaints without prejudice based upon plaintiff's failure to appear for deposition:
  - a. Beverly Day, Docket No. L-9117-06; and
  - b. Maria del Consuelo Rodriguez, Docket No. L-9062-07.

The motions to dismiss set forth in Paragraph 4 shall be returnable no earlier than **June 29, 2011**.

5. The next case management conference shall be conducted on **July 5, 2012 at 10:00 a.m.** in **courtroom 403**. Any joint agenda items and submissions shall be submitted to the court by **noon** on **June 28, 2012**.
6. A copy of this order shall be posted on line by the court within seven (7) days of the date of this order.
