



Addendum to court's order compelling PSS e-mails:

- a. Within ten (10) days of the date of this order, plaintiffs' counsel in the three (3) bellwether cases shall identify two (2) Pharmaceutical Sales Specialists ("PSS") in each bellwether case from whom plaintiffs seek e-mails.
- b. Defendants AstraZeneca LP and AstraZeneca Pharmaceuticals LP ("AZ") shall search the live e-mail account of each selected PSS (to the extent that a live e-mail account may exist) as well as the files on the hard drive of the laptop computer of each selected PSS saved with a file extension of ".PST" or ".MSG."
- c. The PSS e-mails shall be searched for the following terms: "Seroquel," "SQ," "SQL," "quetiapine," "weight gain," and the names of plaintiffs' treating healthcare professionals.
- d. The timeframe for the PSS e-mail search shall be from the launch date of Seroquel® to the earlier of the following time periods: (i) date of plaintiff's last prescription for Seroquel® or (ii) the last date of the PSS's last contact with plaintiff's prescribing healthcare professional.
- e. AZ shall produce the PSS e-mails from the three (3) bellwether cases to plaintiffs' counsel on or before December 22, 2010.
