ORDERED that Sundeep Grewal, Esq. is removed from practicing *pro hac vice* before this Court for all purposes and in all proceedings referenced above, it is further


ORDERED that the *pro hac admission* of Sundeep Grewal, Esq. in these matters, be and hereby is WITHDRAWN. and it is further


