CASE MANAGEMENT ORDER No. 43

THIS MATTER having come before the court on February 17, 2011 concerning the case management of all pending New Jersey state cases in the above-captioned litigation, and good cause having been shown;

IT IS on this 18th day of February, 2011 *effective from the conference date;*


ORDERED as follows:

1. Counsel for AstraZeneca may file a motion regarding the confidentiality of Dr. Blenkinsopp's deposition transcript prior to the next scheduled case management conference.
2. No later than the close of business on **February 17, 2011**, counsel for defendant AstraZeneca shall provide to counsel for plaintiffs the contact information for Paul Woods.
3. As to Max Apel (L-10623-09) and Cherie Lauderdale (L-6714-06), defendant Janssen may file motions to dismiss plaintiffs' complaints without prejudice for failure to comply with Case Management Orders No. 4 and 4-A, to be returnable no earlier than **March 18, 2011**.
4. As to Theodore Ferrara (L-6987-06), defendant Janssen may file a motion for failure to comply with Case Management Order No. 4, to be returnable no earlier than **March 18, 2011**.
5. As to Jacqueline Griffith (L-6707-06), prior to the next scheduled case management conference, plaintiff's deposition shall be completed by telephone.

6. As to Gerald Cesal (L-6901-06), prior to the next scheduled case management conference, plaintiff's counsel shall provide to counsel for defendant Janssen an affidavit, certification and/or stipulation from Ottawa Guardian Services setting forth any and all personal knowledge as to plaintiff's medical condition and the basis/source of the individual's knowledge.
7. On or before **March 17, 2011**, plaintiffs' counsel shall provide to counsel for defendant Janssen specific dates/times for the depositions of the plaintiffs listed below or, in the alternative, an explanation as to the inability of any of the following plaintiffs to travel to New Jersey for their deposition.
