CONSENT ORDER


THIS MATTER having been presented to the Court at the January 14, 2009 Case Management Conference, and the Court having discussed with counsel the production of Releases that may have been executed by plaintiffs in cases pending before this Court in favor of Eli Lilly and Company with respect to the resolution of Zyprexa-related claims or lawsuits; and the parties having consented hereto; and good cause appearing;

IT IS on this 2 day of April, 2009, **ORDERED**:

1. Counsel for the AstraZeneca and Janssen defendants (“Defendants”) may request of defendant Eli Lilly and Company (“Lilly”) the production of Releases that memorialize the settlement of Zyprexa-related claims or litigation signed by specifically identified plaintiffs;

2. Thereafter, Lilly shall, without waiver of any objections, produce to the Court for in camera review copies of the requested Releases (with any settlement amounts redacted), in order that the Court may determine whether to require disclosure of those documents to Defendants’ counsel.

All parties are to be served within seven (7) days of the date hereof.
