This matter being opened to the court by Derek T. Braslow a New Jersey attorney and the attorney of record for Tom Campbell to permit Yvonne M. 2. Yvonne M. Flaherty shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as her agent upon whom service of process may be made for all actions against Stryker Orthopaedics that may arise out of her participation in the matter.

3. Yvonne M. Flaherty shall immediately notify the court of any matter affecting her standing at the Bar of any other jurisdiction.

4. Yvonne M. Flaherty shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.

5. Yvonne M. Flaherty cannot be designated as trial counsel.


6. No discovery, motion trial or any other proceeding delay shall occur or be requested by reason of the inability of Yvonne M. Flaherty to be in attendance.

7. Yvonne M. Flaherty must, within ten (10) days pay the fees required by R. 1:20-1 and R. 1:28-2 and submit an affidavit of compliance.

8. *Pro Hac Vice* admission will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1 (b) and R. 1:28-2.

9. Non-compliance with any terms of this order shall constitute grounds for removal.

10. A copy of this order shall be served on all parties within seven (7) days of the date hereof.
