January 1, 2018 - December 31, 2018

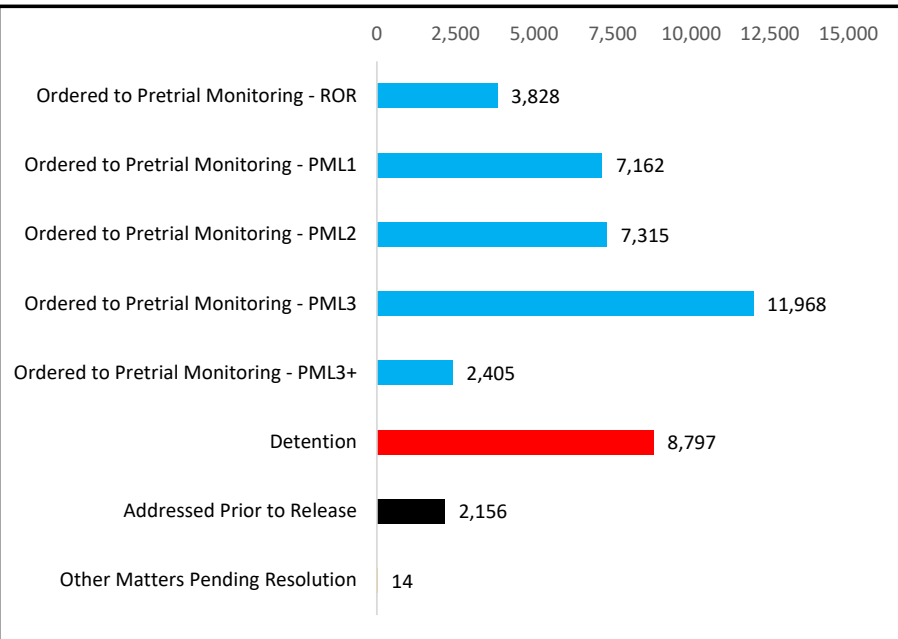

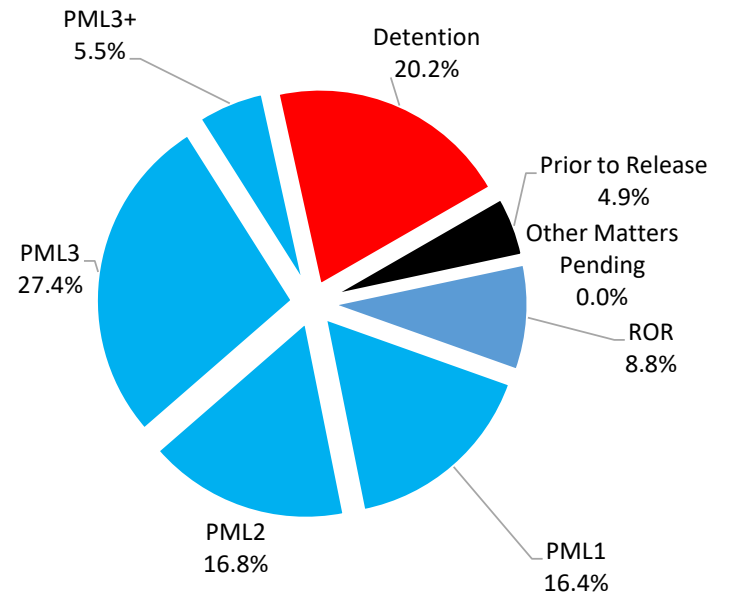

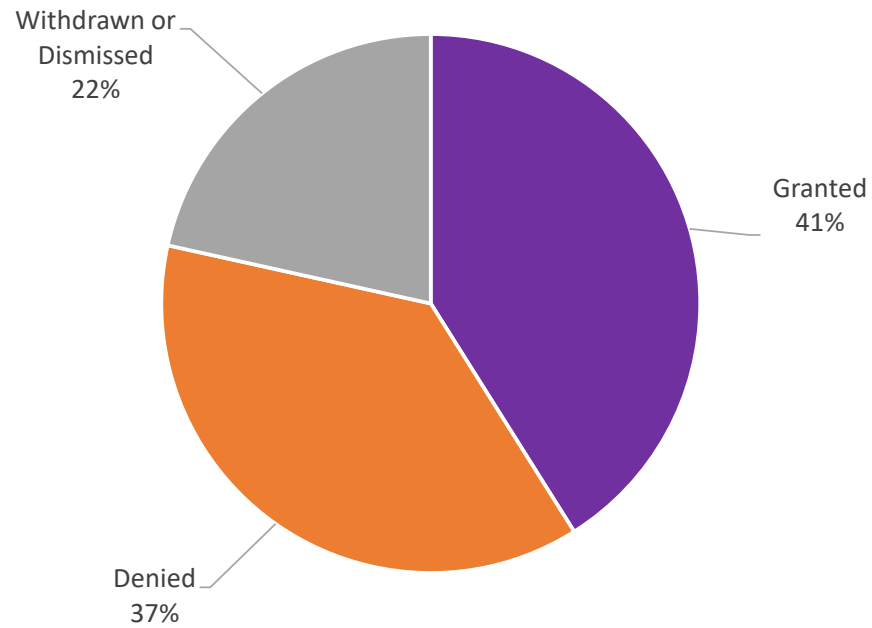

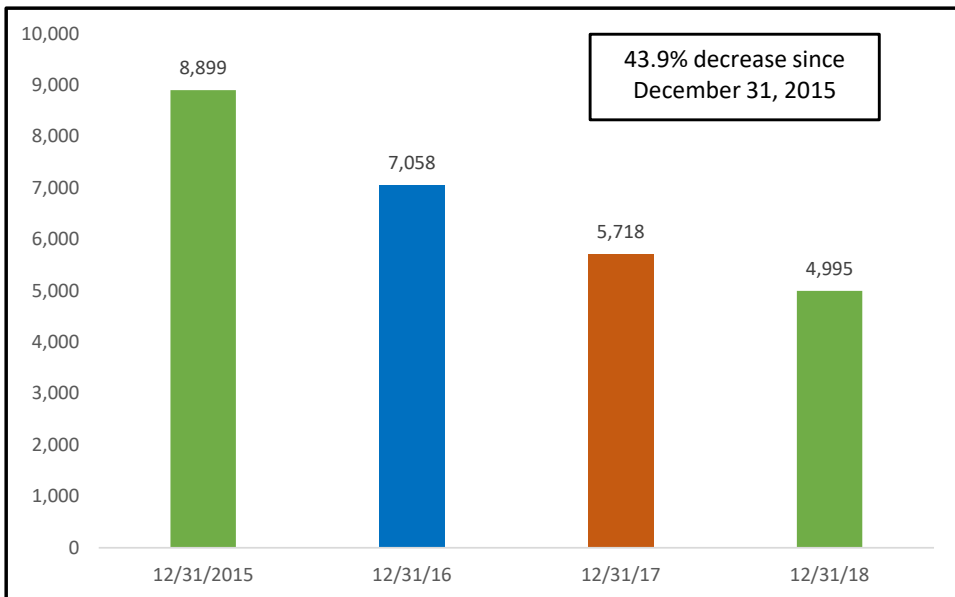
The Burlington County Jail female inmates were moved to Atlantic. This table does not show the Burlington females in Atlantic but shows them in Burlington.

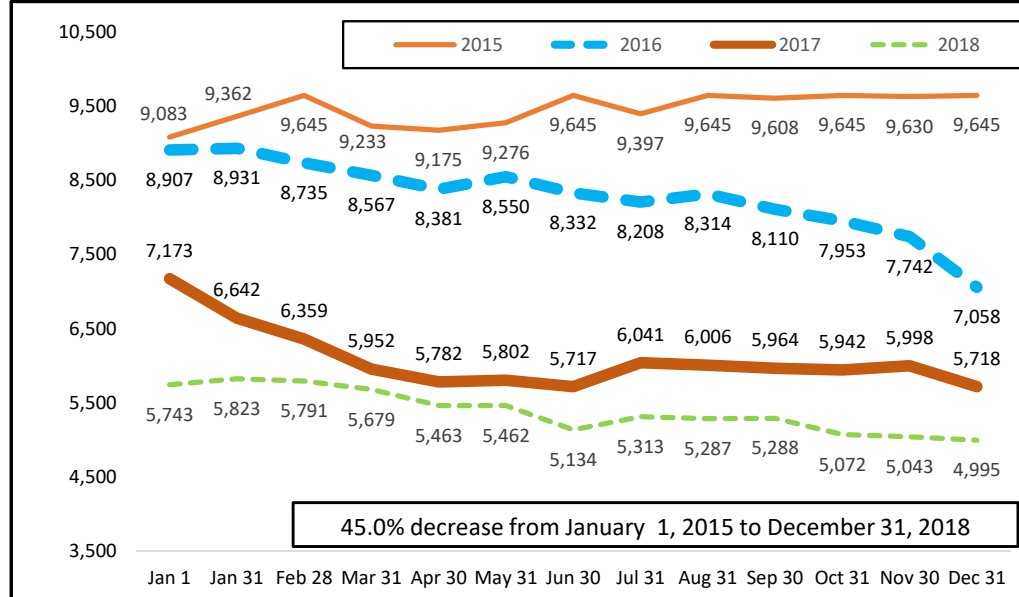

December 31, 2015-2018

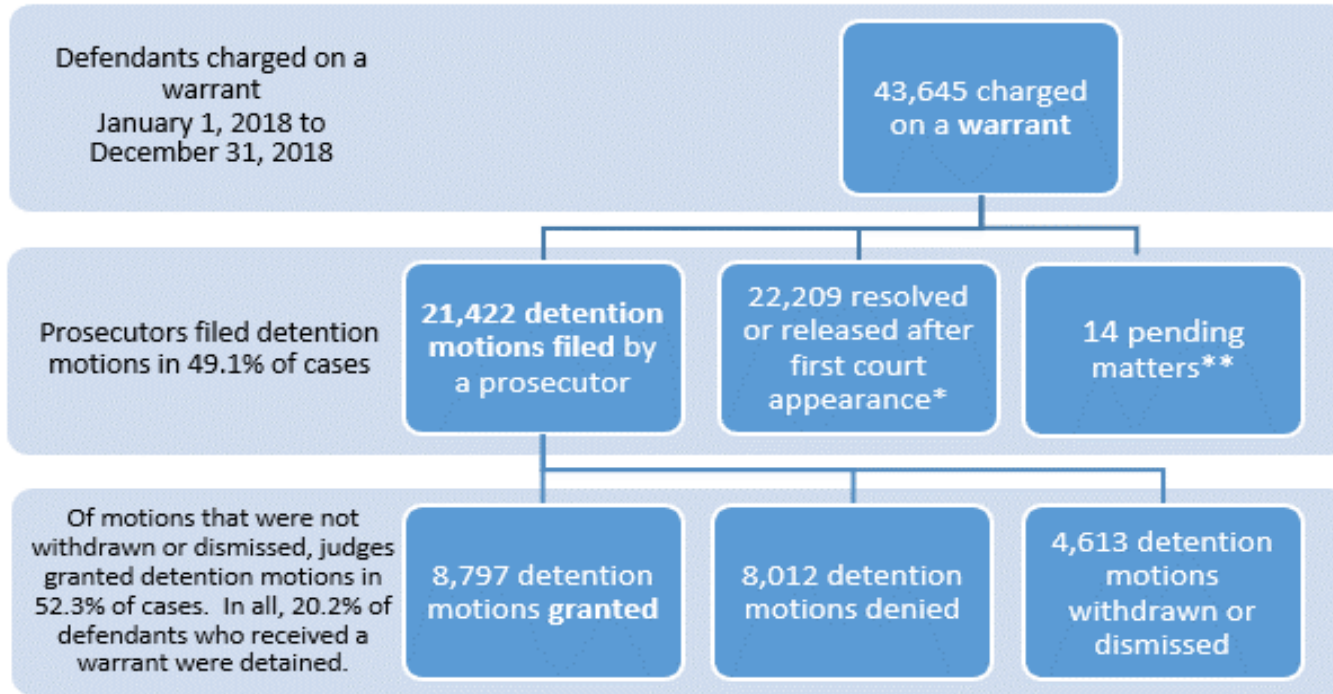


Jan - Dec 2015, Jan - Dec 2016, Jan - Dec 2017, and Jan - Dec 2018

Chart D (Warrant) Pretrial Detention Decisions January 1, 2018 - December 31, 2018

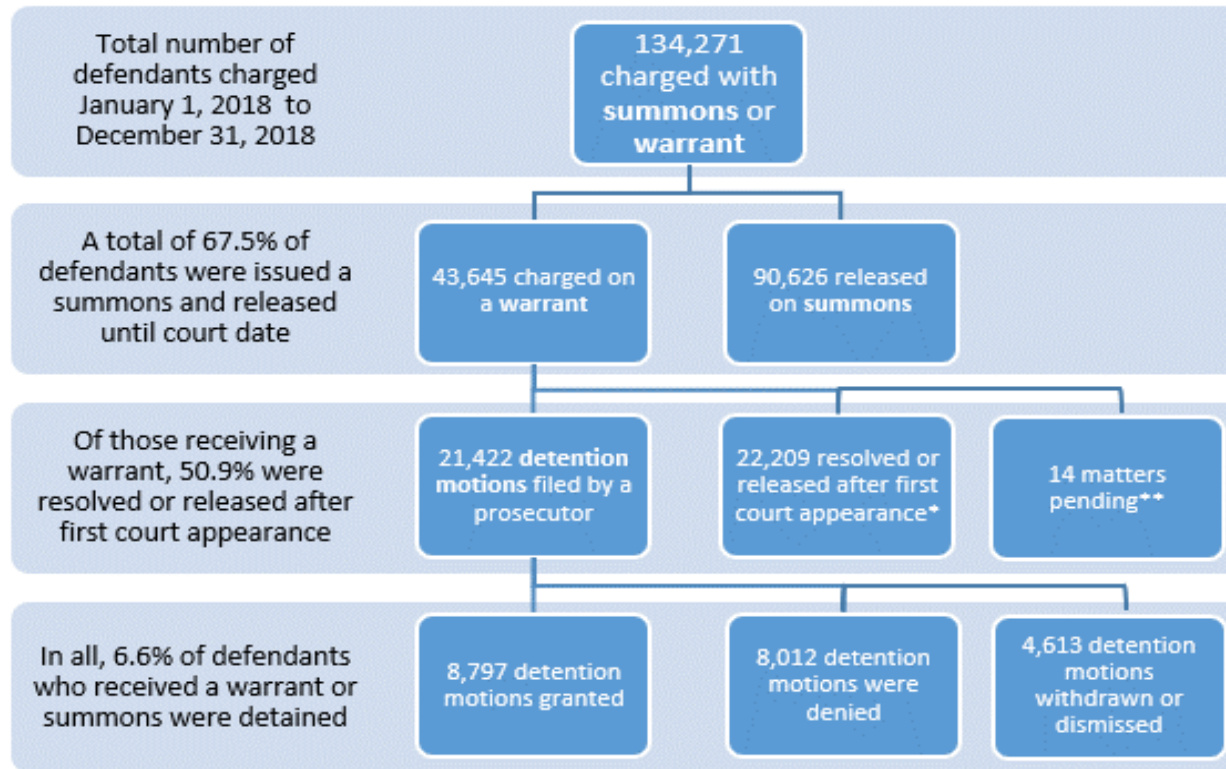
