POSITION DESCRIPTION AND REQUIREMENTS

The County of Atlantic is seeking a qualified individual for the position of Associate Judge of the Central Municipal Court of Atlantic County which is comprised of the eight municipalities of Egg Harbor Township, Estell Manor, Galloway Township, Hamilton Township, Linwood, Northfield, Ventnor and Weymouth. The activities of the Central Municipal Court will be conducted in facilities provided within the Atlantic County Government Center located at 5901 Main Street, Mays Landing, Hamilton Township, New Jersey. Candidates should have prior experience as a municipal court judge and be familiar with the processes and procedures for the disposition of matters in the Central Municipal Court pursuant to the Rules Governing Practice in the Municipal Courts, 7:1 through 7:14-5. It is anticipated the Associate Judge will conduct 6 sessions per week with all virtual sessions to occur on Monday and Friday and in person trials and proceedings on Tuesday, Wednesday and Thursday of each week. The Associate Judge will also be required to handle such administrative matters as may be required pursuant to the Rules of Court and procedures instituted by the New Jersey Administrative Office of the Courts. Candidates must meet the requirements as set forth in N.J.S.A. 2B:12-4 and 12-5. The Associate Judge must attend all training programs required by the State Administrative Office of the Courts, and all training programs as required by the Atlantic/Cape May County vicinage.

The Associate Judge will be required to be on call 24 hours a day/7 days a week to handle probable cause/warrant decisions, Temporary Restraining Orders (TRO's) and other like matters.

The Associate Judge will be a contracted employee of the County pursuant to the terms of a written contract. In accordance with this arrangement, the successful candidate will be permitted to maintain a private law practice, provided that such practice does not conflict with the Associate Judge's duties and responsibilities to the Central Municipal Court.
