THIS MATTER having been opened to the Court jointly by lead counsel for the plaintiffs and defendants, and for good cause shown,

IT IS on this 24 day of **July, 2009**;

ORDERED as follows:

1. This Order supersedes all prior Orders and modifies the deadlines previously set forth in Case Management Order No. 11.

SCHEDULE FOR BELLWETHER CASE DISCOVERY

2. Fact discovery for the bellwether cases shall end on **September 28, 2009**.
3. Choice of law motions, if any, shall be filed by **September 28, 2009**.

4. Plaintiffs' expert reports for the bellwether cases shall be served on or before **October 1, 2009**.

5. Defense expert reports for the bellwether cases shall be served on or before **December 1, 2009**.

6. No expert may testify at trial unless his/her report is served in accordance with the terms of this order.

7. All experts for the bellwether trial cases shall be deposed on or before **January 15, 2010**.

FIRST BELLWETHER TRIAL

8. The parties shall exchange proposed exhibit lists, witness lists, and deposition designations no later than **February 5, 2010**.

9. The parties shall serve objections and counter deposition designations no later than **February 19, 2010**.

10. The parties shall serve proposed exhibit objections no later than **February 26, 2010**.

11. Dispositive, in limine and Kemp motions shall be filed according to the following schedule. If either party wishes to file dispositive motions earlier, this issue should be presented to the court.

- i. File Motion: **February 5, 2010**
- ii. File Opposition: **February 19, 2010**
- iii. File Reply: **February 26, 2010**
- iv. Oral Argument: *To be scheduled*

12. The parties shall submit trial briefs no later than **February 5, 2010**.

13. One page joint statement of the case for the jury pool and joint submission of questions for the jury voir dire to be submitted to the Court no later than **February 12, 2010**.

14. The parties shall submit final exhibit lists no later than **March 8, 2010**.

15. Proposed joint jury charges and verdict sheet shall be submitted to the Court no later than **March 8, 2010**.

16. All of the aforementioned documents filed with the Court shall be filed by **12:00pm** on the due date.

17. The trial of the first bellwether case shall begin on **April 5, 2010**.
