Plaintiffs James Crowe and Charlene Guss, and Defendants Bristol-Myers Squibb Company, Sanofi-Aventis U.S. LLC, Sanofi-Aventis U.S. Inc., and Sanofi-Synthelabo, Inc., by and through their respective undersigned counsel, stipulate and agree as follows, subject to approval by the Court:

1. Plaintiffs hereby dismiss their cases without prejudice, subject to the terms and conditions set forth herein.
2. Plaintiffs shall re-file their complaints, if at all, in the U.S. District Court for the District of New Jersey within seven (7) days of Court approval of this stipulation. Plaintiffs shall designate the cases as related to the Plavix® cases pending before U.S. District Judge Freda Wolfson. Defendants fully reserve all applicable defenses, except that the filing date of the

complaints re-filed in the U.S. District Court for the District of New Jersey shall be considered the same as if the cases had remained pending in the Superior Court of New Jersey Law Division, Atlantic County, for purposes of any defenses based on applicable statutes of limitation or repose.

3. Should Plaintiffs not re-file their first amended complaints in the U.S. District Court for the District of New Jersey within seven (7) days of Court approval of this stipulation, these cases shall be deemed dismissed with prejudice.


