CASE MANAGEMENT ORDER

The Court having conducted a conference on January 3, 2006 with Alan Sklarsky, Esq., Williams Cuker Berezofsky, counsel for plaintiff, Richard Godshall, Esq., Billet & Connor, counsel for defendant, J.B. Laboratories, Inc., and Edwin R. Matthews, Esq. and Lisa A. Grattan, Esq., Bourne Noll & Kenyon, counsel for defendant, Steritek, Inc.,

IT IS on this 25th day of January, 2006, ORDERED:

1. The Court shall vacate the Default previously entered against defendant, Eric Kuhrts, and permit him to file an Answer.
2. Steritek, Inc. shall produce a designated representative for deposition within thirty (30) days of this Order.
3. J.B. Laboratories, Inc. shall produce Cheryl Granlund for a deposition in Holland, Michigan within forty five (45) days of this Order.
4. Eric Kuhrts shall appear in New Jersey for his deposition within forty-five (45) days of this Order.

5. Steritek, Inc. shall provide responses to the existing written discovery demands of the parties within ten (10) days of this Order.

6. Steritek, Inc. shall serve interrogatories upon the plaintiff requesting information regarding factual support for all of the plaintiff's allegations against Steritek, Inc. within ten (10) days of this Order.

7. Eric Kuhrts shall provide a response to plaintiff's Document Demand within thirty (30) days of this Order.

8. All defendants's summary judgment motions asserting statutory defenses to plaintiff's claims shall be returnable before the Court on March 31, 2006.

9. Moving papers shall be due on March 3, 2005; opposition shall be due on March 21, 2006; and reply papers shall be due on March 27, 2006.

7. The next case management conference shall be held in the afternoon of March 31, 2006.
