only for the purposes of the Propulsid litigation and not disclosed beyond counsel of record and their staff.



If the parties cannot resolve the issues relating to confidentiality of the MIS documents identified on Exhibit A to the letter of April 25, 2001, defendants shall file a formal motion for a Protective Order for proprietary, trade secret or confidential documents on or before June 30, 2004, to continue the terms of this Order beyond June 30, 2004, unless the parties agree to modify this Order by consent. In the interim the documents shall subject to the terms of this Order.




