2. The parties will meet and confer regarding the status of these documents. If the parties cannot resolve the issues relating to confidentiality of the MIS documents identified on Exhibit A to the letter of April 25, 2001, defendants shall file a formal motion for a Protective Order for proprietary, trade secret or confidential documents on or before April 11, 2003, to continue the terms of this Order beyond April 11, 2003, unless the parties agree to modify this Order by consent. In the interim the documents shall subject to the terms of this Order.




