

# NOTICE TO THE BAR

## CIVIL CASE INFORMATION STATEMENT (CIVIL CIS) – REVISIONS TO SIDE 2 REGARDING TRACK IV CASE TYPES

The Civil Case Information Statement (“Civil CIS”) is included in the Rules of Court as Appendix XII-B1. The Supreme Court previously delegated to the Administrative Director the authority to approve revisions to Side 2 of the Civil CIS. This Notice is to advise the bar of the approval of several such revisions to Side 2. The complete Civil CIS as revised is attached. No changes have been made to Side 1. The approved revisions, which are **effective December 1, 2010**, are as follows:

- the addition of case types 603N and 603Y to identify more specifically auto negligence-personal injury cases as either verbal threshold or non-verbal;
- the addition of case type 290 for the Pompton Lakes litigation, pursuant to the Supreme Court’s September 13, 2010 Order centralizing the management of the litigation but not designating it as a mass tort;
- the addition of case type 291 for the Pelvic Mesh (Johnson & Johnson) litigation, pursuant to the Supreme Court’s September 13, 2010 Order centralizing the management of the litigation but not designating it as a mass tort;
- the addition of case type 292 for the Pelvic Mesh (Bard) litigation, pursuant to the Supreme Court’s September 13, 2010 Order centralizing the management of the litigation but not designating it as a mass tort;
- the removal of case type 619 for the Vioxx litigation, pursuant to the Supreme Court’s October 26, 2010 Order terminating the mass tort designation and centralized management of the litigation; and
- the removal of case type 272 for the Bextra/Celebrex litigation, pursuant to the Supreme Court’s October 26, 2010 Order terminating the mass tort designation and centralized management of the litigation.


