

NOTICE TO THE BAR

CIVIL CASE INFORMATION STATEMENT (CIVIL CIS) – REVISION TO SIDE 2 REGARDING PELVIC MESH LITIGATION

At the November 18, 2010 initial case management conference in the Pelvic Mesh (Johnson & Johnson) litigation (case type 291), Judge Carol E. Higbee ordered that the name of that litigation be changed from “In re: J&J Litigation” to “In re: Pelvic Mesh Litigation/Gynecare.”

The Supreme Court has delegated to the Administrative Director of the Courts the authority to approve revisions to Side 2 of the Civil CIS. Accordingly, the Administrative Director has approved the following revision to Side 2 of the Civil CIS, to be effective January 3, 2011:

- Case type 291, formerly identified as the Pelvic Mesh (Johnson & Johnson) litigation, is now identified as the Pelvic Mesh Litigation/Gynecare.

The complete Civil CIS as revised is attached. No changes have been made to Side 1 of the Civil CIS.


