Surety Bond Registry; Revised Bail Program Registration Form

This directive outlines a change in the bail registry procedure pursuant to N.J.S.A. 17:31-13 which requires that "a surety company shall register with the Clerk of the Superior Court the name and address of each bail agent or agency authorized by the surety company to write bail."

The Office of the Superior Court Clerk maintains the Surety Bond Registry containing contact information for all corporate insurance companies, their bail agencies, agents and guarantors of surety bonds. To be authorized to post bail in the State of New Jersey, one must be active in the Surety Bond Registry. To register an agency or agent with the Clerk of the Superior Court for inclusion in the Registry, a corporate sponsor must complete and submit a Bail Program Registration Form. Corporate sponsors have "a continuing obligation to update [their] Bail Program Registration Forms as changes occur in order to assure that the information is complete and accurate." Rule 1:13-3(d). Furthermore, failure to update the Bail Program Registry Form shall result in removal from the Surety Bond Registry upon 30 days' notice. Rule 1:13-3(e)(1).

The Clerk of the Superior Court, pursuant to the provisions of Rule 1:13-3(e)(2), is responsible for removing a corporate surety, its agencies, and its agents for failure to satisfy outstanding bail judgments. In such situations where there has been removal and where one or more bail forfeiture judgments naming the removed registrant, agency, administrator, managing agent or guarantor remain open, the Clerk of the Superior Court shall deny any request to add any agents of that removed entity to the registry as agents for another entity pursuant to Rule 1:13-3(d). Additionally, as to authorized agents that have one or more outstanding bail judgments but have not been removed from the Registry, the Clerk of the Superior Court shall deny any request to add such agent to the registry as an agent for another entity pursuant to Rule 1:13-3(d).

The Bail Program Registration Form required by Rule 1:13-3(d) has been revised and is being promulgated as part of this directive. New information that must be set forth on the completed form includes a list of bonds authorized by the insurer to be posted by the registrant. This list must specify the power of attorney number and be updated accordingly pursuant to Rule 1:13-3(d). The revised form captures the name, license number and license expiration date of the managing agent as well as the trade name, if any, for agencies, which should include "bail agency" or "bail bonds". In addition, the signature of the guarantor is mandatory along with a certification by the insurer that all judgments have been satisfied prior to the registration request.
