ANSWER OF RESPONDENT

Respondent by way of answer to the complaint says:

- 1. Paragraph 1 is admitted.
- 2. Paragraphs 2 a. c. are admitted except that respondent believes that he did not begin serving in Ringwood until 1993. Respondent further notes that he has taken a voluntary leave of absence without pay from his judicial positions pending the resolution of the within complaint.
- 3. Paragraph 3 is admitted. Respondent further notes that he has taken a voluntary leave of absence without pay from these positions pending the resolution of the within complaint.
- 4. Paragraph 4 is admitted except that respondent ceased being a member of the firm on or about October 15, 2010.
- 5. As to paragraph 5, respondent admits that the law firm of Perconti and Cook ceased doing business as of October 15, 2010 and

that he began his own law firm subsequent thereto. That firm employs former associates of Perconti and Cook.

- 6. Paragraph 6 is admitted.
- 7. Paragraph 7 is admitted.
- 8. Paragraph 8 is admitted but respondent notes that Sean Caposella was the Chief Executive Officer of Jefferson Loan.
- 8a. Paragraph 8a is admitted except that Jefferson Loan voluntarily decided to liquidate in December 2006.
- 8b. As to paragraph 8b., it is admitted that subsequent to December 2006 Jefferson Loan continued to operate to collect outstanding loans that it had made. Jefferson Loan is no longer in operation; Valley National Bank is collecting Jefferson Loan's outstanding loans.

COUNT ONE

- 9. As to paragraph 9, Respondent repeats his answer to paragraphs 1-8 as if set forth at length herein.
- 10. As to paragraph 10, respondent admits that he has been named a party in numerous lawsuits.
- 11. Paragraph 11 is admitted.
- 12. Paragraph 12 is admitted.
- 13. Paragraph 13 is admitted.
- 14. Paragraph 14 is admitted except that the Court's findings were limited to plaintiffs and that the actual award of damages was \$71,000.00. Pre-judgment interest of \$28,400.00 was also awarded.

Respondent specifically denies that he breached his fiduciary duty.

15. As to paragraph 15, respondent admits that there are substantial outstanding monetary judgments on which he is jointly and severally liable. Most of these judgments are based on personal guarantees by respondent of obligations owed by limited liability companies which owned real estate. Respondent further states that he believes that he is entitled to a fair market credit on certain of these judgments and that he is in the process of attempting to resolve most of these outstanding judgments. Respondent further admits that one of his creditors has garnished his salaries in the municipalities where he is a municipal judge.

- 16. Paragraph 16 is denied.
- 17. As to paragraph 17, respondent admits that on June 3, 2009 a deed regarding the Beach Haven property, which respondent executed on August 16, 2008, was recorded. That deed transferred respondent's interest in property located in Beach Haven New Jersey, which he held with his wife as tenants by the entirety, to his wife. There was no lawsuit by plaintiff Kleinert pending at that time. Nor had the debt to plaintiff Kleinert matured at that time. Respondent further admits that he drew a deed for his wife, which she executed on April 8, 2010, transferring the Beach Haven Property which she held alone at that time to her daughter and herself. That deed was recorded on June 2, 2010. Respondent further admits that there was litigation pending at the time of

this transfer seeking to void the first transfer referred to in this paragraph and that the second transfer was found to be a fraudulent transfer and voided by a summary judgment Order dated April 15, 2011. A notice of appeal has been filed from that Order. Respondent specifically denies any intent to defraud creditors.

17a. As to paragraph 17a, respondent admits that the plaintiff referred to therein filed a fraudulent transfer suit and that an Order was entered on October 4, 2010 as a result of a telephone status conference on September 23, 2010. That Order provided that plaintiff could – to the extent it obtained a final judgment on a lawsuit pending in Monmouth County – attach respondent's interest in certain properties to the extent that respondent had an interest prior to any transfers. The Court did not make any findings of fact and respondent specifically denies any allegation that he had any intent to defraud creditors.

- 17b. Paragraph 17b is admitted subject to respondent's answer to paragraph 17. That summary judgment Order is on appeal. Respondent specifically denies any intent to defraud creditors.
- 18. As to paragraph 18, respondent admits that the Orders referred to therein were entered but denies that he was attempting to avoid creditors.
- 19. Paragraph 19 is denied.
- 20. Paragraph 20 is admitted. Respondent was unaware of this directive which was issued prior to respondent becoming a municipal

judge.

- 21. Paragraph 21 is admitted.
- 22. Paragraph 22 is admitted upon information and belief. Respondent notes that he was unaware of the document referred to therein.
- 23. Paragraph 23 is denied.
- 24. Paragraph 24 is denied.
- 25. Paragraph 25 is denied.
- 26. Paragraph 26 is denied.

COUNT II

- 27. As to paragraph 27, respondent repeats his answer to paragraphs 1-26 as if set forth at length herein.
- 28. As to paragraph 28, respondent admits that his law firm made political contributions on behalf of his partner; respondent believed at the time that this was appropriate and did not violate any law or the canons.
- 29. Paragraph 29 is admitted.
- 30. As to paragraph 30, respondent admits that Puddingstone made political contributions and upon information and belief that Jefferson Loan made the contribution referred to therein. Respondent denies that he was a majority shareholder in Puddingstone he owned a 1/3 interest and was not the managing member. Respondent further states that Sean Caposella was the Chief

Executive Officer of Jefferson Loan.

31. As to paragraph 31, respondent denies that he intended to violate the canon prohibiting political contributions but in retrospect believes that the contributions in question should not have been made.

COUNT III

- 32. As to paragraph 32, respondent repeats his answer to paragraphs 1-31.
- 33. Paragraph 33 is admitted. Respondent states that he was not aware that the attorney who handled these matters was handling probable cause hearings and immediately stopped him from doing so upon learning of the same. Respondent further notes that he was not the managing partner of the firm and the attorney who handled the probable cause hearings reported directly to the managing partner.
- 34. Paragraph 34 is admitted.
- 35. Paragraph 35 is admitted upon information and belief.
- 36. Paragraph 36 is admitted. But see answer to paragraph 33.
- 37. Paragraph 37 is denied.

ADDITIONAL FACTORS TO BE CONSIDERED

1. Respondent has been a municipal court judge for over twenty years. During that time period he has gained a reputation as a fair and impartial judge who promoted respect for the law. Annexed as Exhibits A-J are letters from law enforcement officers and practitioners attesting to this fact.
