


Guide to Accessing eCourts Appellate

Effective August 1, 2017, access to eCourts Appellate was granted to all NJ attorneys in good standing status as of June 30, 2017. If you are currently not in good standing status, you will need to be reinstated before access will be granted.

Step 1.

Activate your NJ Attorney ID. If you have never used the Attorney Registration and Contact Information online, go to [Attorney Registration & Contact Information](#) and follow the instructions for **First Time Users – One Time Account Setup**.

If you currently use the Online Registration and Payment Center, your NJ Attorney ID has been activated. Proceed to Step 2.

Firms/Individual Attorneys

1. Login with the unique **User ID and temporary password**.
2. Create your permanent password, make note of it for future use, and submit the requested basic data.
3. Go to your email inbox and click on the link in the activation email that you should have received. If there is no activation email, check your spam or junk folders, then contact us at CPF.Mailbox@njcourts.gov.
4. Add CPF.Mailbox@njcourts.gov to your Address Book to ensure that you receive future notices regarding the annual assessment.

Step 2.

Log into the Judiciary Single Sign On portal (<https://portal-cloud.njcourts.gov/prweb/PRAuth/CloudSAMLAuth?AppName=ESSO>) with your NJ Attorney Bar ID and password. This is the same User ID and Password used to log in and pay your annual attorney registration.
