Municipal Court Reports

The Municipal Courts in New Jersey are considered courts of limited jurisdiction, having responsibility for motor vehicle and parking tickets, minor criminal-type offenses (for example, simple assault and bad checks), municipal ordinance offenses (such as dog barking or building code violations) and other offenses, such as fish and game violations. A Municipal Court has jurisdiction only over those cases that occur within the boundaries of its municipality. Many serious criminal cases, such as robbery, auto theft, or assault, start out as complaints filed in the Municipal Court, however, those cases are transferred to the Superior Court located at the county courthouse.

Note: Electronic information is made available only in the form in which it is maintained or used by the Judiciary, pursuant to Court Rule 1:38. The Judiciary <u>does not</u> engage in custom programming for private interests.

Automated Traffic System

The Automated Traffic System (ATS) processes all the traffic tickets in the State of New Jersey. The ATS database is so large that it takes 5 report segments to produce one report state wide. This report is <u>not</u> a list of active traffic summonses, rather it is a list of all traffic summonses which have been disposed in the preceeding month.
