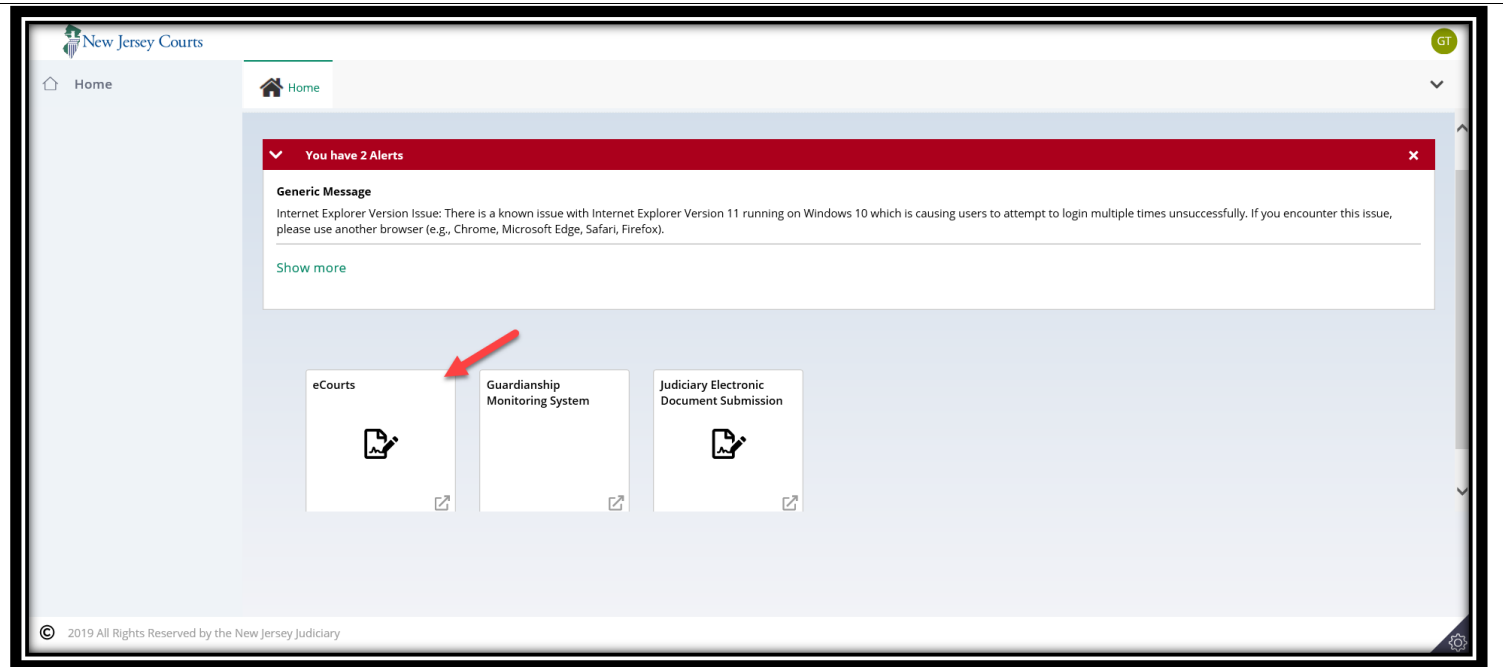


After logging into the Judiciary Portal select eCourts.

The eCourts welcome page will open in another browser. Ensure Guardianship is selected as the Court/Division.

Click on the Case Jacket tab to proceed.



1. Ensure the correct case status and county are selected.
2. Enter a docket number (exactly as shown on the latest Judgment including spaces, dashes and alphanumeric characters).
3. Or enter a first name and last name for the Incapacitated Person.
4. Click **Search**.




Alternatively, from an open report review screen, click on the VIEW CASE JACKET link to directly open the case jacket for the particular case in review.



Case Jacket will display detailed information regarding the case.

The highlighted area will display case details. This information will include essentials such as:

- IP Name
- Venue
- Filed Date
- Case Status
- Guardianship Type


