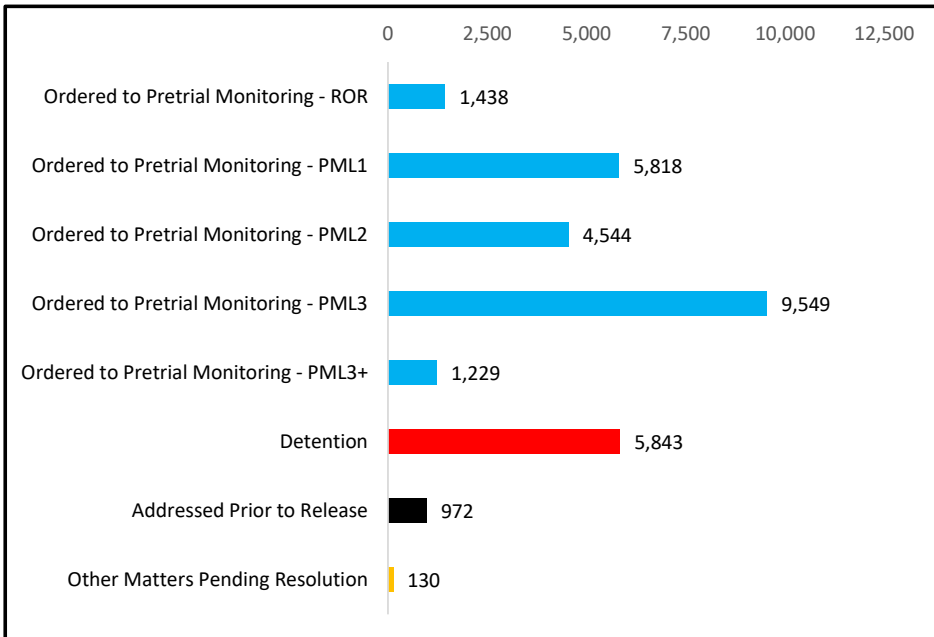

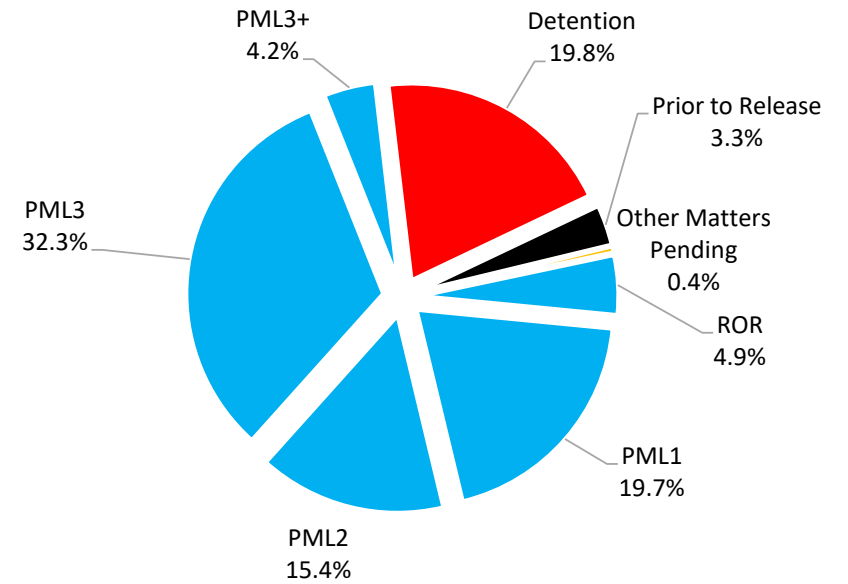

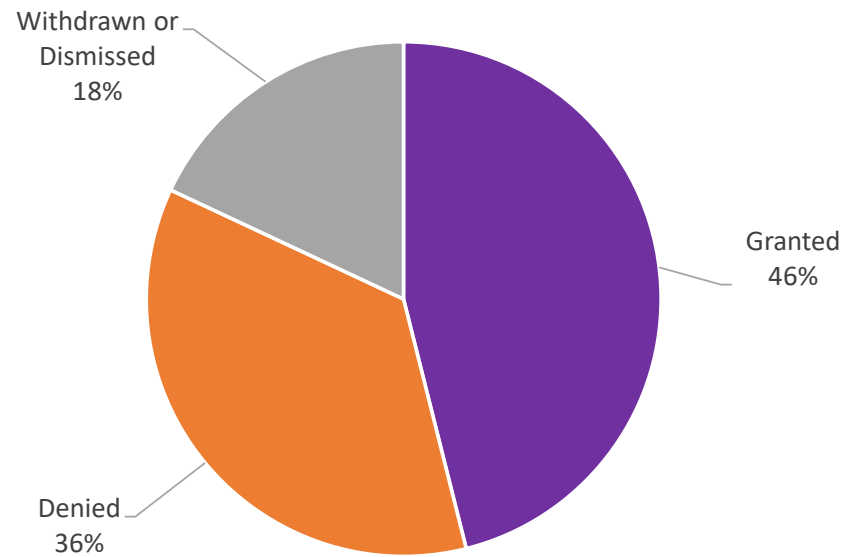

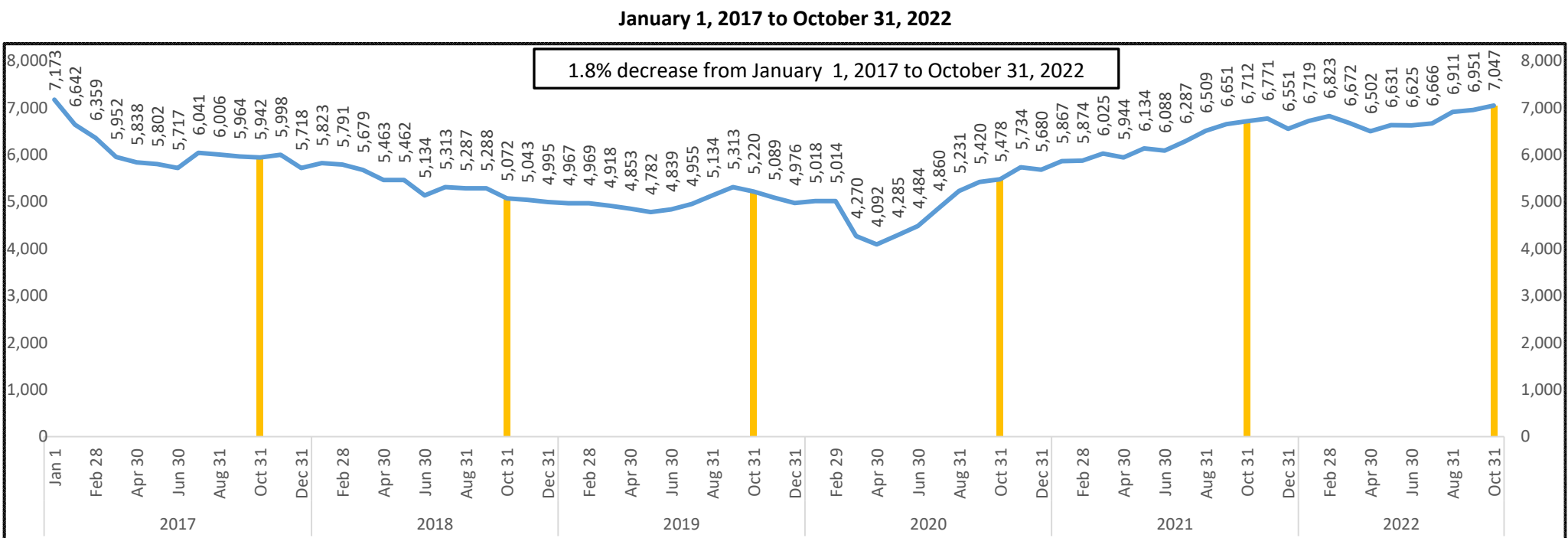
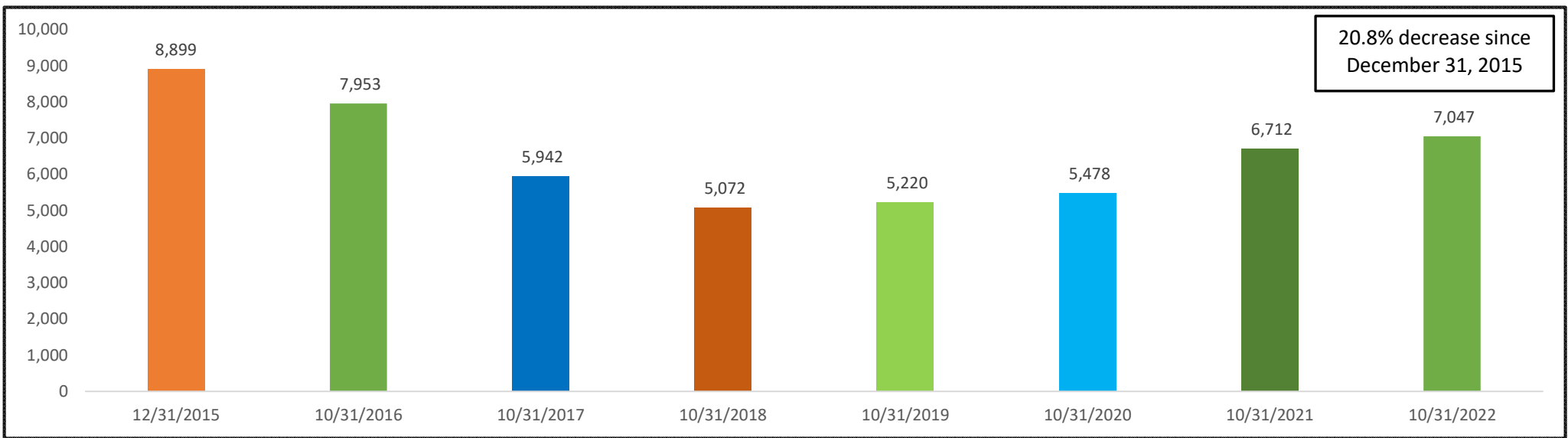
The Burlington County Jail female inmates were moved to Atlantic. This table does not show the Burlington females in Atlantic but shows them in Burlington.

Chart C - Supplemental Graphs Nonsentenced Pretrial Jail Population October 31, 2022 December 31, 2015 and October 31, 2016 -2022



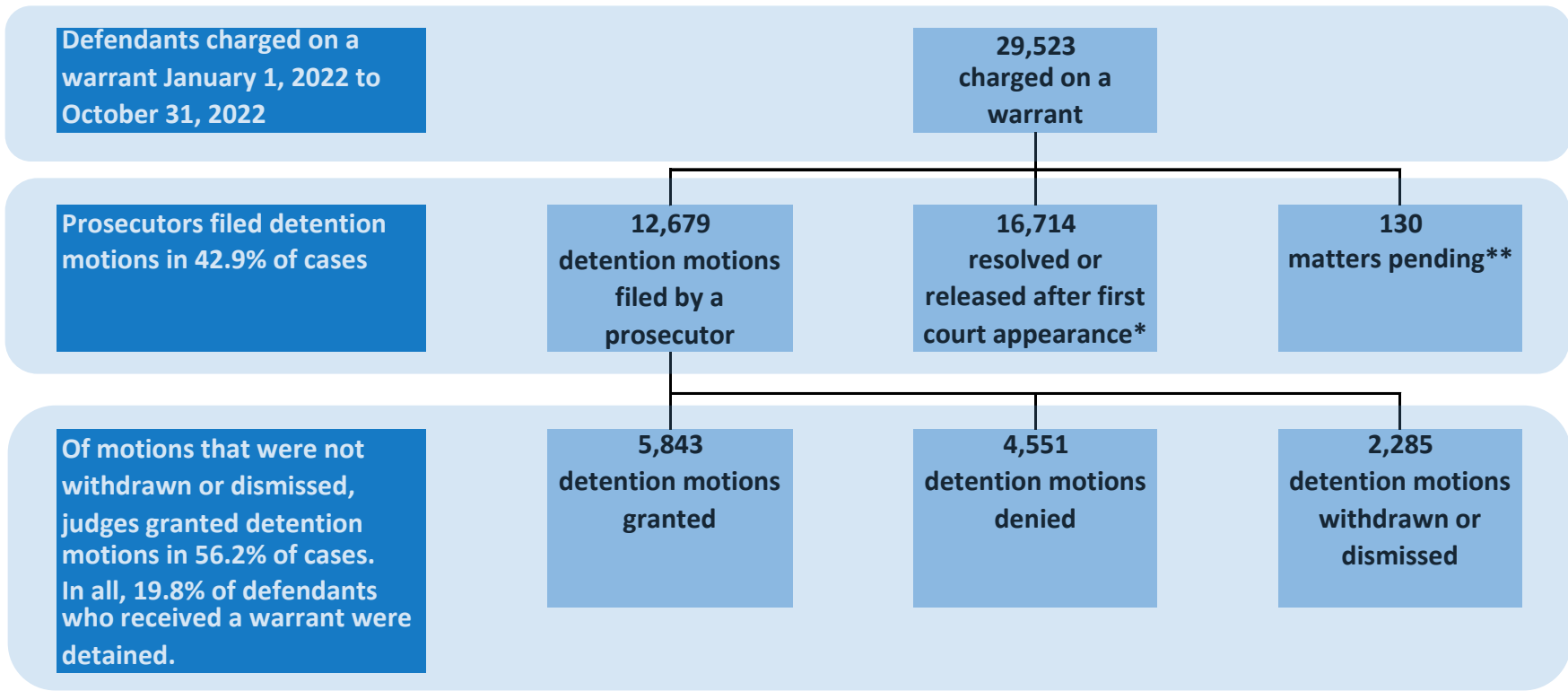

Pretrial Detention Decisions

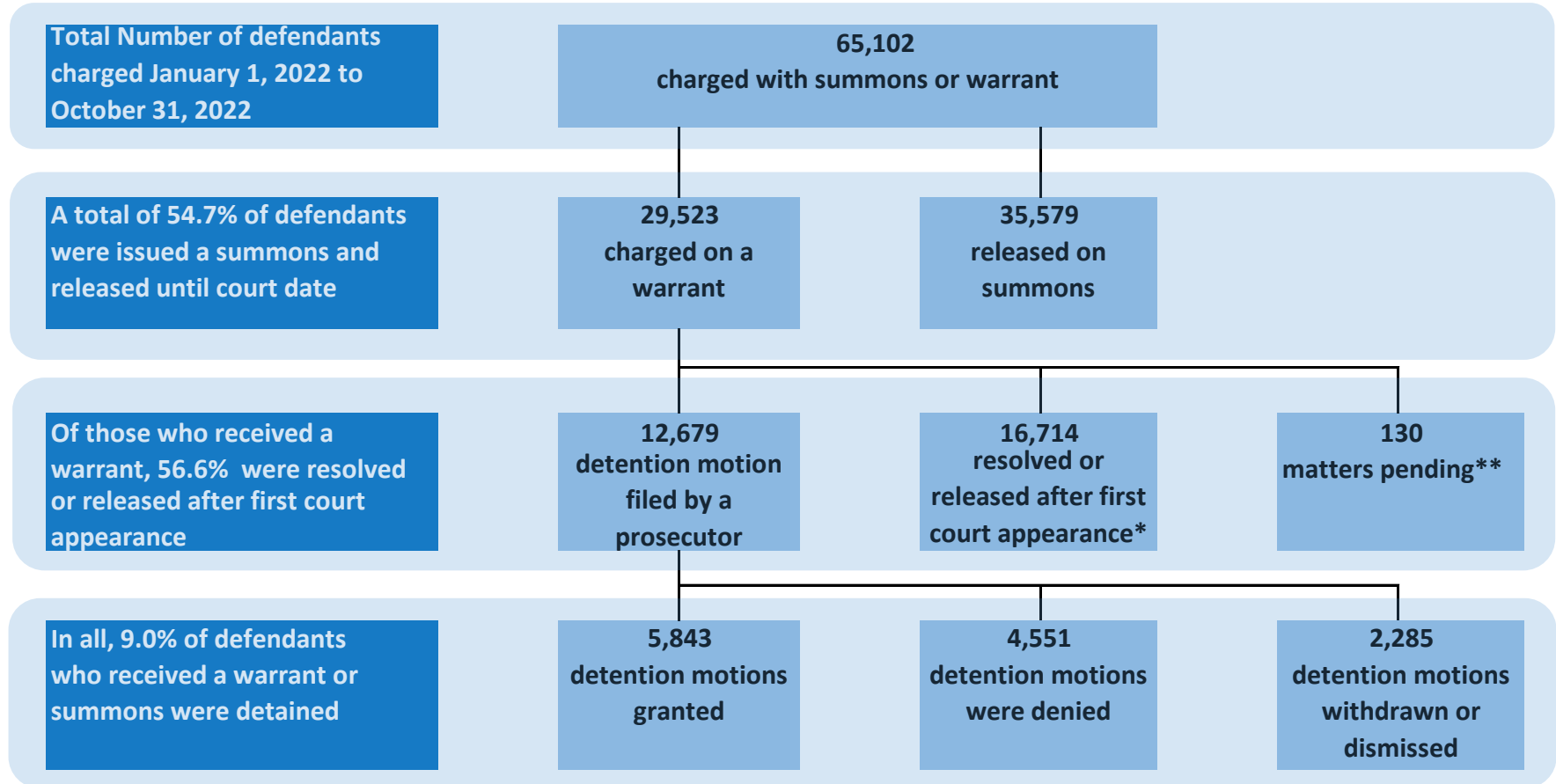
January 1, 2022 - October 31, 2022
