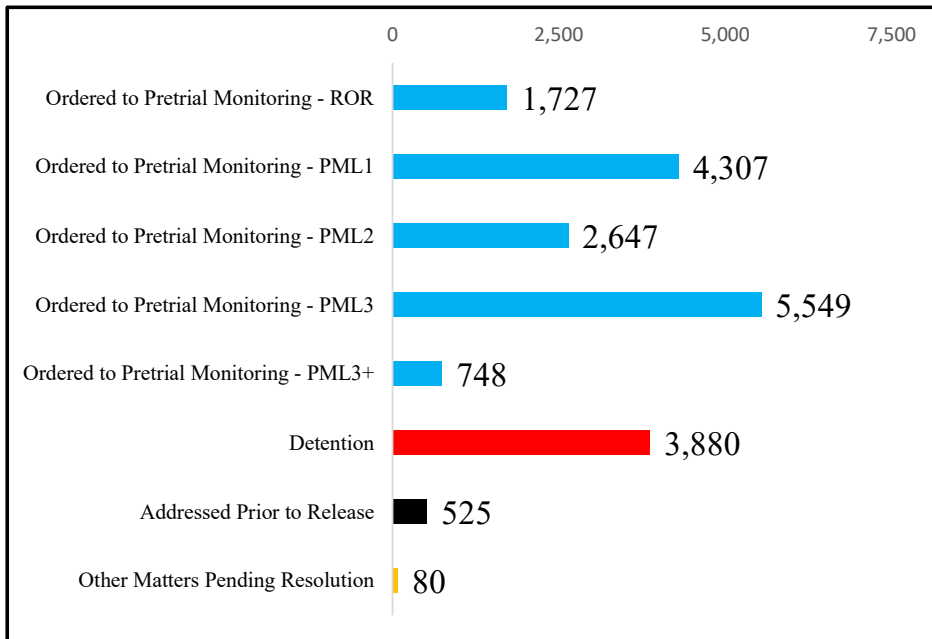

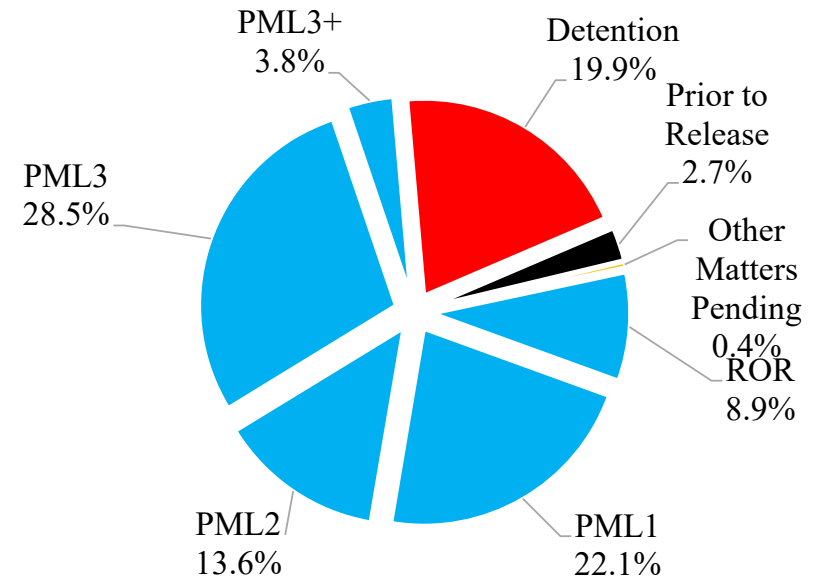

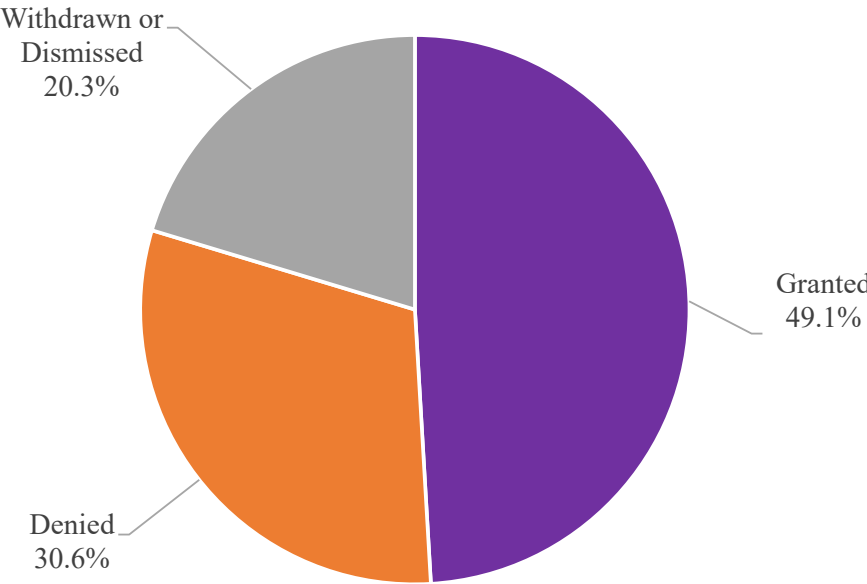

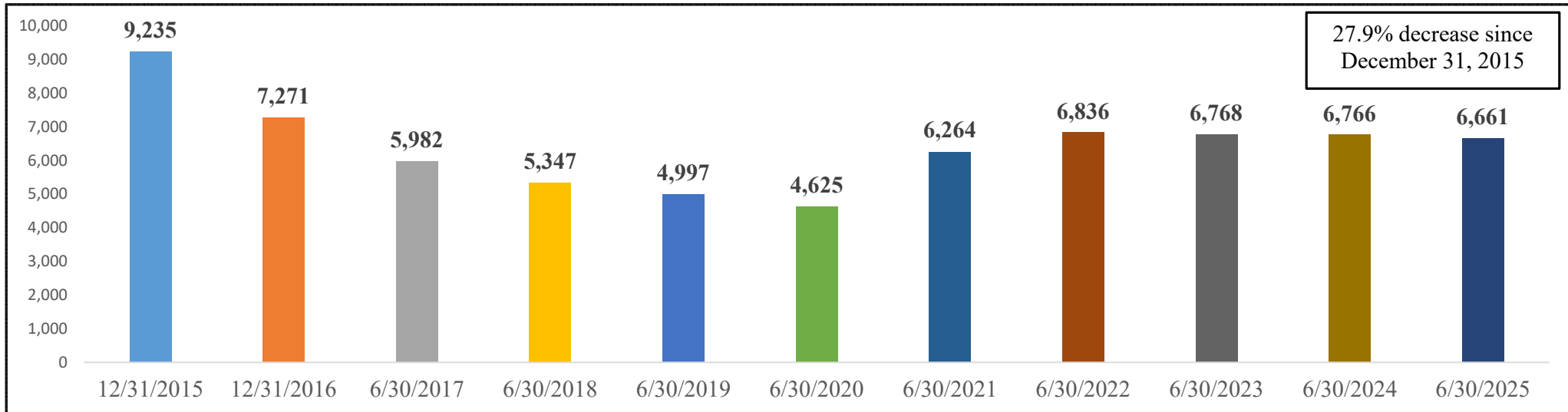

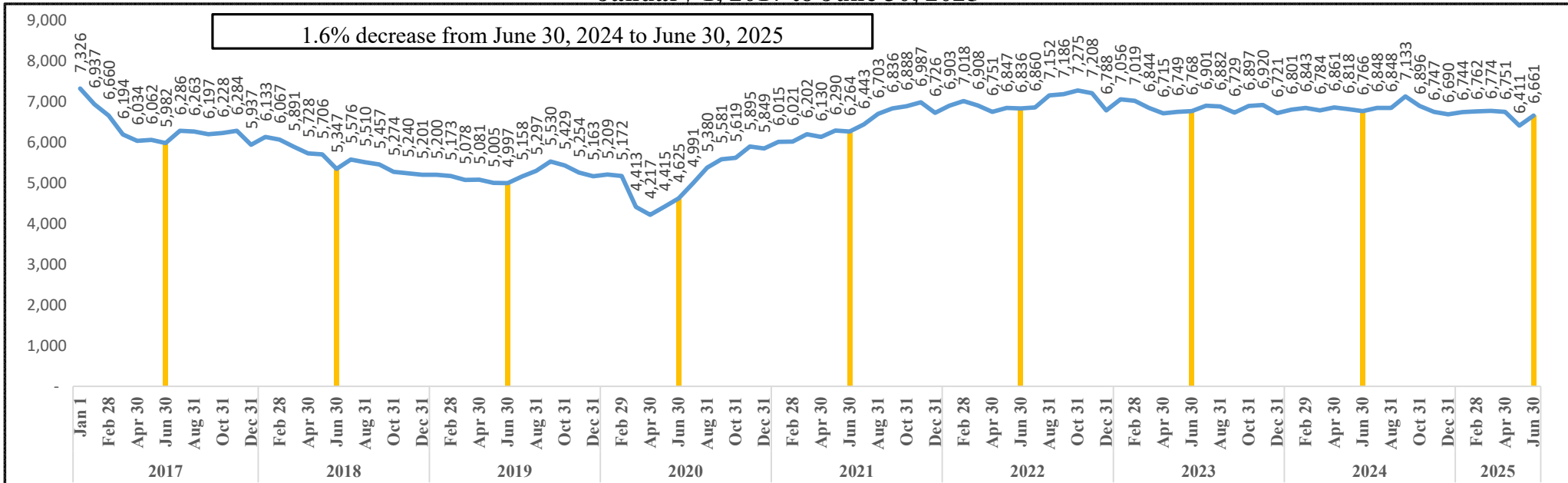

Nonsentenced Pretrial Jail Population



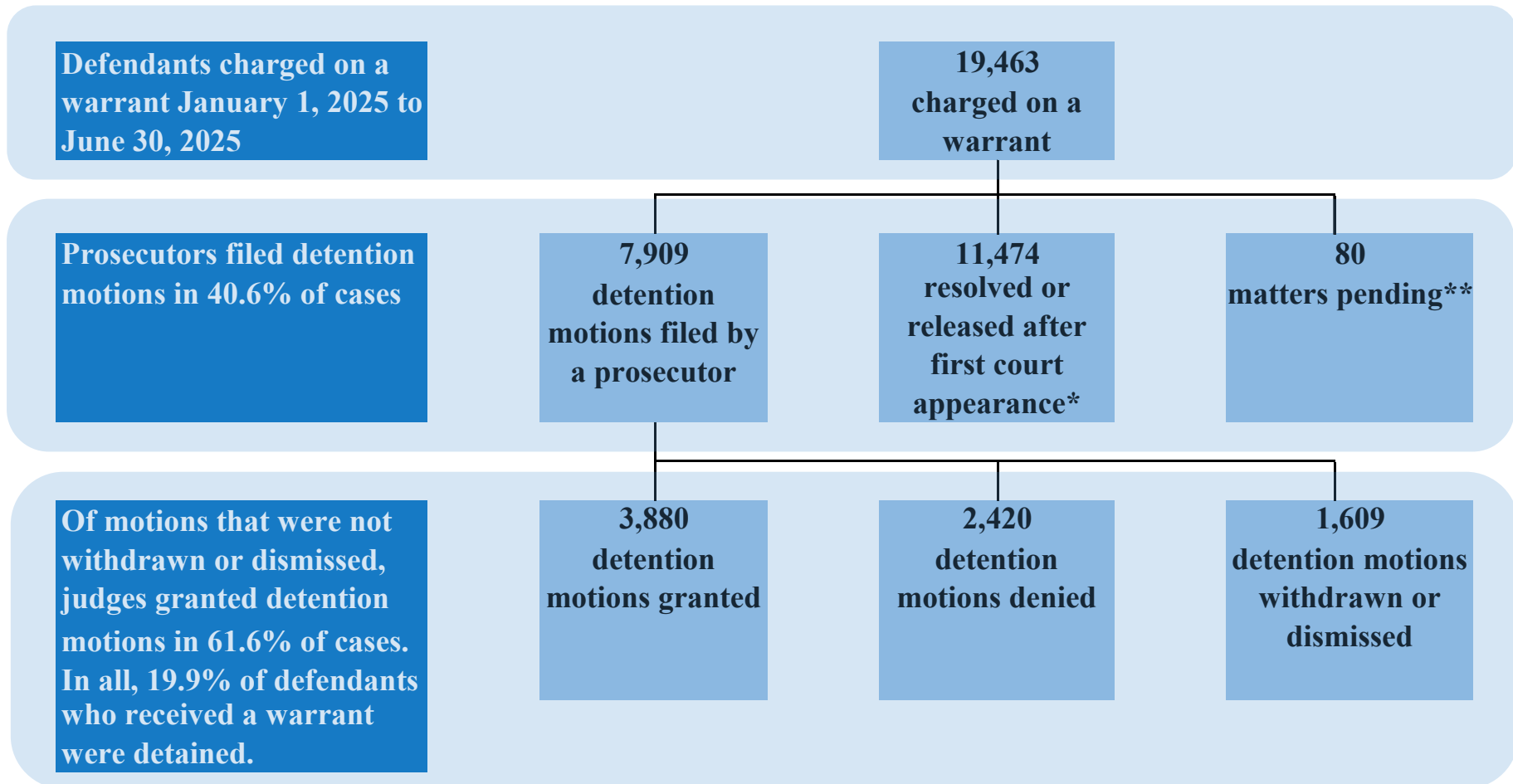
January 1, 2017 to June 30, 2025

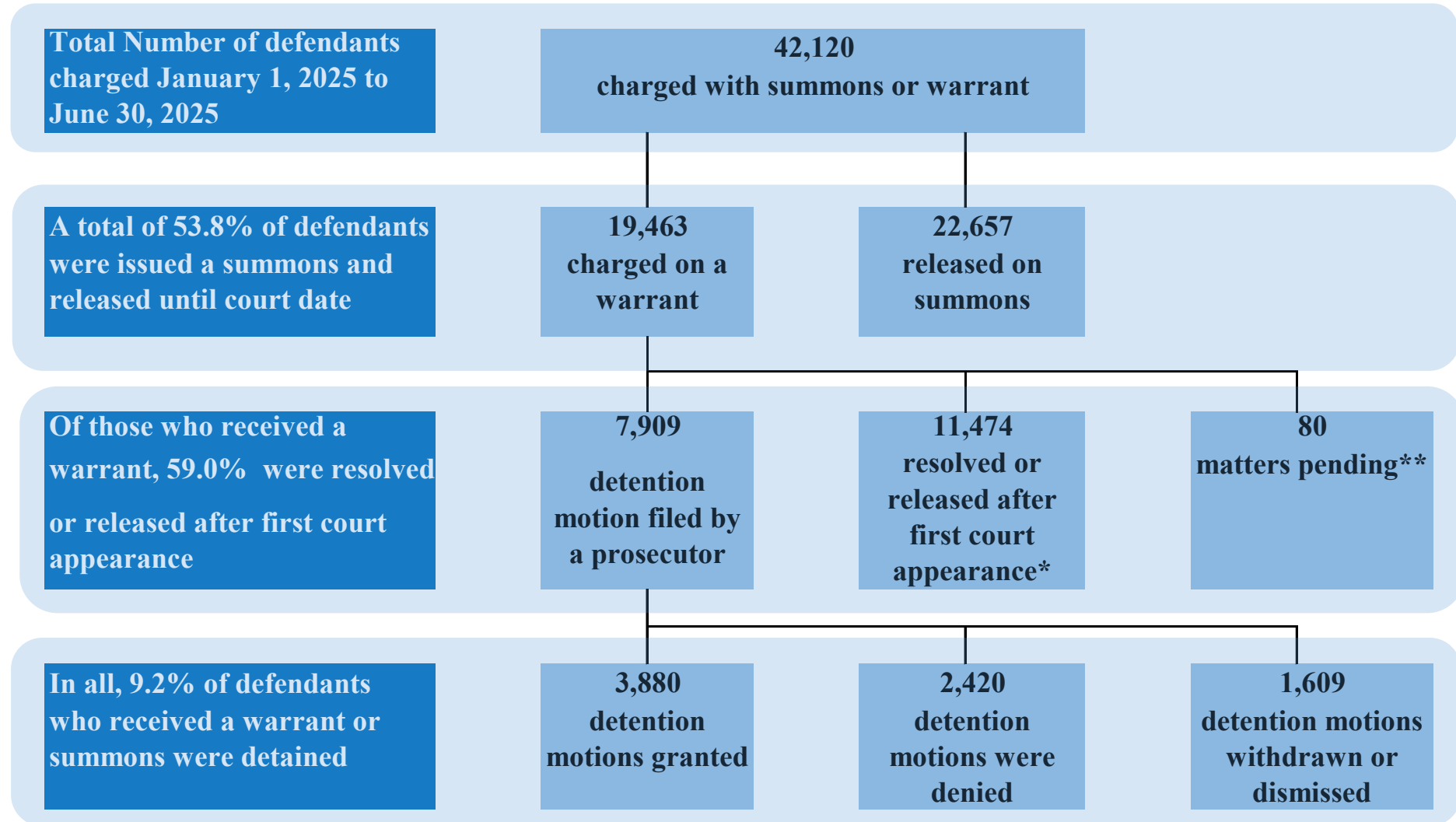
