Gun Permit Appeals System – Prosecutor and LEO training 12/08/2023

#### Overview

- The Gun Permit Appeals System provides a mechanism for processing appeals filed when Gun Permit applications are denied by Law Enforcement agencies.
- The filer (applicant or private attorney filing on behalf of the applicant) submits the appeal in JEDS.
- The County Prosecutor has the option to provide a response to the appeal and upload their response letter in eMACS. They can also upload any other documents necessary for that appeal.
- Judges can review the Appeal and submit an order on the decision or Court staff can submit the order on behalf of the judge. Decision can be to dismiss the appeal, deny the appeal, grant the appeal or grant the appeal in part, deny in part.
- Law Enforcement will be able view Gun Permit appeals in their municipality(s) through eMACS.
- Prosecutors can see the progression of the Appeal in the Case jacket of that Appeal while Law Enforcement will be able to view the latest active order on the Appeal, if there is one.

#### Gun Permit Appeals – Status in the Work Basket

- **Pending Schedule**: An appeal is docketed in Gun Permits system with this status. A schedule has not been created on that appeal at this time.
- Scheduled: There is an open schedule for that appeal.
- Awaiting Judicial Decision: The only open schedule has been closed in ECS with event action of "Completed" but a decision has not yet been made on the Appeal.
- **Completed**: Appeal has been heard and recorded in Gun permits. All open schedules in ECS are closed at this time with event action of Completed.
- **Draft Order**: When an Order is saved on an Appeal, status is Draft Order.
- Withdrawn: Appeal has been withdrawn by the filer.
- **Transferred**: Appeal has been transferred to a different county.
