

# Topics

- Creation of an eCDR complaint via the new Custody Warrant complaint path – *this is in addition to the current “Summons” and “TBD” paths.*
- Submittal to Superior Court for a judge’s determination of Probable Cause and decision on a request to seal.
  - *If Probable Cause is found and the judge authorizes a warrant, the complaint warrant is immediately docketed.*
  - *The case is sealed for 10 days if the judge grants the seal request. This can be extended for another 10 days if requested by the prosecutor prior to the expiration date.*
- RST request to Superior Court when the Juvenile is taken into custody.

From the Portal, click the Juvenile Central Registry tile which is required to create a Juvenile complaint.

## Welcome - Juvenile Central Registry

The Juvenile Central Registry is a computerized inquiry system that allows law enforcement to access information about juvenile delinquency cases. The JCR system permits direct access, at any time, to certain juvenile information in FACTS.

The system displays juvenile delinquency cases filed in the Family Part's FJ docket. Law Enforcement personnel can use this information to help with investigating alleged criminal behavior by a juvenile.

- 1. To Be Determined:** Requiring the juvenile to be in the custody of the officer submitting the complaint.
- 2. Summons:** Submission directly to court.
- 3. Custody Warrant:** Requiring the juvenile to NOT be in the custody of law enforcement. Prosecutor/Senior Officer review is **mandatory**

The remaining slides focus on the “Custody Warrant” flow.

The Custody Warrant path can be selected only when the Juvenile is NOT in Law Enforcement's custody  
\*\*\*Note: The Law Enforcement Officer can request an order to seal the case. By default, N is displayed.



**Preliminary Law Enforcement Incident Report**

**Purpose:** The Preliminary Law Enforcement Incident Report (PLEIR) is intended to document basic information known to the officer at the time of its preparation. ## Probable Cause Determination by a Superior Court judge.

Three possible outcomes:

1. Probable Cause found and a Warrant is authorized – *a complaint warrant document will be generated and made available to the officer. If so requested and granted, the case will be sealed for 10 days.*
2. Probable Cause found, but a warrant is not authorized – *the officer will have the option to submit that complaint to court as a Summons*
3. Probable Cause not found – *no further action can be taken*



Once the Superior Court judge determines Probable Cause and authorizes a Warrant, the eCDR complaint will be displayed in the **“Juvenile Custody Warrants”** workbasket – ***accessible to law enforcement officers statewide.***
