## Supplemental Plea Form Mandatory Sentence to Special Probation Pursuant to N.J.S.A. 2C:35-14.2 "New Jersey Recovery Court"

The following questions need to be answered only if you are eligible for a <u>mandatory</u> sentence of special probation pursuant to *N.J.S.A.* 2C:35-14 ("Recovery Court").

- 1. Do you understand that the court has determined or may determine that you  $\Box$  Yes  $\Box$  No are a drug dependent person?

Do you understand that if the court determines that you are drug dependent □ Yes □ No and also finds that you meet the criteria in *N.J.S.A.* 2C:35-14, you may be eligible to be sentenced to a mandatory period of special probation for the purpose of participating in a court-supervised drug treatment program ("Recovery Court")?

This criteria includes, but is not limited to, a finding that: (1) you are a drug or alcohol dependent person, and (2) that you were drug or alcohol dependent at the time of the commission of the present offense, and (3) that you did not possess a firearm at the time of the present offense or any pending charge, and (4) that you do not have certain prior disqualifying convictions, and (5) there is suitable treatment available for you, and (6) no danger to the community will result from your serving a "Recovery Court" sentence.
