May 12, 2017	Defendants shall serve answers to standard interrogatories by this date.
May 31, 2017	Plaintiff shall propound supplemental interrogatories and document requests by this date.
June 30, 2017	Defendants shall serve answers to supplemental interrogatories and document requests by this date.
May 31, 2017	Defendants shall propound supplemental interrogatories and document requests by this date.
June 30, 2017	Plaintiff shall serve answers to supplemental interrogatories and document requests by this date.

June 30, 2017 Plaintiff depositions shall be concluded by this date. Plaintiff's counsel shall contact the Special Master within one week of this deadline if plaintiff depositions are not completed by this date.

date or waive any opportunity to rely on liability expert testimony.

ECONOMIST EXPERT REPORTS

October 31, 2017 Plaintiff shall identify its expert economists and serve expert economist report(s), if any, by

this date or waive any opportunity to rely on economic expert testimony.

December 15, 2017 Defendants shall identify its expert economists and serve expert economist report(s), if any,

by this date or waive any opportunity to rely on economic expert testimony.
