September 25, 2015 Settlement demands shall be served on all counsel and the Special Master by this date.

SUMMARY JUDGMENT MOTION PRACTICE

September 25, 2015 Plaintiff's counsel shall advise, in writing, of intent not to oppose motions by this

date

October 9, 2015 Summary judgment motions shall be filed no later than this date.

November 6, 2015 Last return date for summary judgment motions.

MEDICAL DEFENSE

September 30, 2015 Plaintiff shall serve medical expert reports by this date.

September 30, 2015 Plaintiff is to arrange for the transfer of pathology specimens and x-rays, if any, by this

date.

December 31, 2015 Defendants shall identify its medical experts and serve medical expert reports, if

any, by this date. In addition, defendants shall notify plaintiff's counsel (as well as all counsel of record) of a joinder in an expert medical defense by this date.

LIABILITY EXPERT REPORTS
