ORDER

THESE MATTERS, having been brought before the Court by way of proposed Consent Orders agreed to by all Parties extending Defendants' time to answer, move, or otherwise respond to the Complaint;

WHEREAS, Plaintiffs filed these actions in the Superior Court of New Jersey, Law Division, Bergen County;

WHEREAS, Plaintiffs allege that they suffered damages in connection with an implantable port catheter device;

WHEREAS, Plaintiffs have sought multicounty litigation ("MCL") designation of actions alleging injuries in connection with Defendants' implantable port catheter devices;


WHEREAS, Defendants have opposed MCL designation, and have filed motions to dismiss a number of actions identified in the MCL application;

WHEREAS, the Parties agreed to extend Defendants' deadline to answer, move, or otherwise respond to Plaintiffs' Complaints in this action in light of the pending MCL application and pending motion to dismiss;

WHEREAS, on October 15, 2024, the Supreme Court entered an Order designating that these actions be designated as multicounty litigation;

IT IS on this 10TH day of April, 2025 **ORDERED**, as follows:

ORDERED that, for all cases identified on the attached Exhibit A, Defendants shall answer, move, or otherwise respond to the Complaints within 60 days of the Court's initial Case Management Order in the MCL or a date to be determined following any initial Case Management in the MCL.
