CASE MANAGEMENT ORDER NO. 2

THIS MATTER having come before the Court for a case management conference on November 7, 2008, and counsel for plaintiffs and counsel for defendant Bristol-Myers Squibb Company ("BMS") having been present and for good cause shown,

IT IS on this | 5 day of \_\_\_\_\_\_, 2008,

ORDERED that except to the extent inconsistent with the terms of the within Case

Management Order ("CMO"), all prior CMO's remain in full force and effect, and it is further

ORDERED as follows:

#### I. DISCOVERY FROM DEFENDANT BRISTOL-MYERS SQUIBB COMPANY

1. On or before December 15, 2008, defendant BMS shall produce for inspection and copying those documents responsive to request No. 1 contained in Plaintiffs First Request for Production of Documents.

2. On or before February 1, 2009, defendant BMS shall produce for inspection and copying all documents sent to, or received from, the New Jersey Department of Environmental Protection, that are related to the allegations set forth in plaintiffs' Master Complaint.

#### II. DISCOVERY FROM PLAINTIFFS

- 3. On or before March 1, 2009, plaintiffs' counsel shall provide answers to the following Interrogatory questions previously served on plaintiffs' counsel (as modified during the conference): 1, 2, 3, 4, 5, 6 (limited to personal injury), 8, 10, 13, 14, 20, 21, 22, 23, 24, 26 (modified to change "this action" to "your condition"), 33, 34 and 35.
- 4. Plaintiffs' counsel shall provide copies of any and all medical, hospital, treatment or other records received for each plaintiff within five days of receipt. Plaintiffs' counsel shall simultaneously provide a duly executed HIPAA compliant authorization for each medical provider from whom a record is produced.

## III. <u>MISCELLANEOUS MATTERS</u>

5. Both parties agree that the inadvertent production of any document or other information during discovery in this action shall not result in the waiver of any associated claim that the document or other information is protected by any legally cognizable privilege or evidentiary protection including, but not limited to, the attorney-client privilege or the work product doctrine. Upon written notice of an unintentional production by the producing party, the receiving party must promptly return or destroy the specified document and any hard copies the receiving party has, and may not use or disclose the information until the privilege claim has been resolved, unless the receiving party disagrees that the document or information is privileged in which case the receiving party shall so notify the producing party within ten days. The producing party may then apply to the court for a declaration that the document or information is

privileged, in which event, the receiving party will promptly return or destroy the specified document.

- 6. The parties shall meet and confer regarding the terms of a Confidentiality Agreement, which shall be executed by December 10, 2008, or a phone conference on the same shall be arranged with the court by counsel prior to that date.
  - 7. CMO 1, Section III, Paragraph 1, shall be amended as follows:
- a. The obligation of Defendant BMS to preserve physical evidence shall not encompass changes to its New Brunswick physical facility that are undertaken in the normal course of business.
- b. Defendant BMS may continue performing remediation and testing in accordance with plans approved by the New Jersey Department of Environmental Protection, without providing prior notice to plaintiffs' counsel with respect to any such remediation or testing except that in connection with its discovery obligations, defendant shall produce all documents and information sent to or from the New Jersey Department of Environmental Protection regarding its plan for and implementation of continuing remediation, including scheduled sampling, protocols, and test results.
- 8. Oral argument regarding Defendant's Motion to Dismiss Plaintiffs' Spill Act Claims, filed in those cases identified on Exhibit A annexed hereto, and Defendant's Motion to Dismiss Wrongful Death Act Claims, filed in those cases identified on Exhibit B annexed hereto, shall take place on Wednesday, December 10, 2008 at 10:00 a.m., at the Atlantic County Courthouse, Courtroom 3-B, 1201 Bacharach Boulevard, Atlantic City, New Jersey.
- 9. Plaintiffs' counsel has agreed to voluntarily dismiss Bristol-Myers Company and E.R. Squibb & Sons, Inc. from these actions, neither entity having been served by plaintiffs.

Bristol-Myers Squibb Company acknowledges that to the extent there is any claimed liability, which is expressly denied by it, for any of the actions alleged in the Complaints with respect to the facility more particularly described in Paragraph 16 of the Master Complaint, that Bristol-Myers Squibb Company is the correct legal entity to respond to those claims.

- 10. Counsel for Bristol-Myers Squibb Company shall prepare and forward to counsel for plaintiffs the Voluntary Stipulations of Dismissal with respect to E.R. Squibb & Sons, Inc. and Bristol-Myers Corporation and, after execution by plaintiffs' counsel, shall file the Stipulations with the Court.
- 11. The next case management conference will be held on Thursday, March 5, 2009 at 10:00 a.m., at the Atlantic County Courthouse, Courtroom 3-B, 1201 Bacharach Boulevard, Atlantic City, New Jersey.
- 12. No adjournments or extensions of any dates for production of documents can be made, even by an agreement of the parties, without permission of the court
