IT IS on this 14th of June 2021, hereby:

ORDERED that within 45 days of the date of this Order, plaintiffs shall serve on defendants a fully complete, updated, and executed Plaintiff Fact Sheet ("PFS") pursuant to Case Management Order No. 3, including ink-signed medical authorization forms and all medical records and documents responsive to PFS, Section IX, including but not limited to all

contemporaneous medical records that document an alleged Levaquin-related event; and it is further

ORDERED that Defendants' request that by 90 days of the date of this Order, plaintiffs shall serve on defendants a case specific expert report from a physician who is licensed to practice medicine in the United States and qualified to render a specific causation opinion addressing to a reasonable degree of medical probability when and how, if ever, plaintiff experienced a Levaquinrelated event based on contemporaneous medical records attached to the report is hereby **DENIED without prejudice**; and it is further

ORDERED that the Motion of Plaintiff's counsel to be relieved as counsel, returnable June 11, 2021, is hereby carried sixty (60) days to Tuesday, August 10, 2021, to be heard via Zoom at 9:00 am; and it is further

ORDERED that no later than forty-five (45) days from the date of this order all counsel may file supplemental briefing in support of their respective positions. This will include, but not be limited to, the forwarding of documents for *in camera* review, if appropriate; and it is further
